Agreed that an IAC Ad Hoc Working Group on Emergency Plans (Operation Alert) be established to study IAC planning problems of Operation Alert 1956, and to examine the impact of war upon the functions of the IAC.

7. Proposal for NIE
(ONE Memorandum to IAC representatives, 17 February; letter of Mr. Armstrong to DCI, 23 February)

Agreed to initiate an NIE for early IAC consideration on certain aspects of Soviet policy and the vulnerability of under-developed areas to the Soviet economic offensive.



- c. Agreed to establish an IAC standing committee to study intelligence aspects of this subject.
- d. The Chairman undertook to raise with the Operations Coordinating Board the desirability of forming an interdepartmental advisory committee to consider all aspects of exchange of persons and delegations with the Soviet Bloc.


