

6. NIE 11-4-57  
Main Trends in Soviet Capabilities  
and Policies, 1957-1962

The Chairman emphasized the importance of this estimate, and suggested that particular attention be given to the manner and form in which the paper, or its substance, is passed to the highest policy-makers. The members then exchanged views on various aspects of the estimate, and on a number of proposed amendments. In this connection, the members agreed, upon completion of the forthcoming SNIE 11-10-57, "Probable Development Timetable and Characteristics of the Soviet ICBM," to review the relevant portion of NIE 11-4-57 dealing with Soviet ICBM capabilities (e. g., para. 23 of Section IV, 30 October draft), in the light of SNIE 11-10-57, to determine whether it appeared necessary to circulate to holders of NIE 11-4-57 any changes in that portion of the estimate.

After an extended discussion of NIE 11-4-57, the members agreed not to attempt to take final action at this meeting, and concurred in the Chairman's suggestion that the IAC continue consideration of the paper at a special IAC meeting on Wednesday, 13 November.\*
