



- b. Soviet Internal Situation

The members discussed intelligence and information from various sources bearing on recent internal political developments in the USSR, particularly with respect to the possible significance of Zhukov's dismissal as Defense Minister. After their discussion the members agreed that this should be considered as a "crisis" situation and the Chairman noted that he expected to brief the NSC on these developments.

- c. Other Situations

The members discussed certain matters pertaining to the situation in Berlin.

Mr. Kent invited the members' attention to various factors which appeared to require a review of certain portions of the existing Argentine estimate. After he noted that a CIA memorandum had been prepared on this situation, the members agreed that this memorandum should be distributed to the agencies prior to next week's meeting, at which time the members would review the memorandum and consider

its disposition, including the possibility of the preparation of a coordinated paper.

The Chairman referred to developments in Guatemala and Mr. Kent and Mr. McAfee commented on this situation.

4. Memorandum re  
Soviet Capabilities  
and Intentions  
(IAC-M-312, item 9 a)

Copies of a memorandum on various military factors affecting Soviet capabilities and intentions over the next five years, dated 28 October, were distributed to the members. The Chairman noted that this version of the memorandum, an earlier draft of which had been discussed at last week's IAC meeting and subsequently circulated to the members (IAC-M-312, item 9 a), incorporated changes which he [redacted] had agreed to subsequent to that IAC meeting. The Chairman stated that he had been asked for a briefing on very short notice during the recent talks between the President and Prime Minister Macmillan and had briefed from this paper. However, he also noted that, in briefing, he had advised that various figures appearing in the paper had not been coordinated and that these questions were currently being reviewed by the US intelligence community. More specifically, the Chairman said that he had referred to the fact that the Air Force considered the heavy bomber figures given in the memorandum as too low. Following their discussion, the members agreed that this memorandum should be treated as an IAC document for purposes of the record. (See Secretary's Note No. 1.)

[redacted] comments on this memorandum were distributed, after which the members discussed the question of its revision and possible reissuance as an SNIE. Following their exchange of views, the members agreed not to issue this paper as an SNIE at this time. However, it was also agreed to reconsider the substance of the matters covered in the memorandum at next week's IAC meeting, in the light of [redacted] any further pertinent developments in the USSR or elsewhere, with a view to the possibility of preparing a new paper based on different terms of reference.


9. Department of Defense  
Study on Defense Against  
Ballistic Missiles  
(Report by Ad Hoc Committee,  
24 October; IAC-M-310,  
item 6 b)

The members noted the report of the working group on this proposal and discussed various relevant factors. During this discussion General Collins emphasized the necessity of treating the problem primarily as one involving estimates of future collection capabilities. Following their exchange of views, the members agreed that the study should be undertaken by a working group in the light of this discussion and on the basis of the assumed data given in the initial terms of reference (IAC-D-81/15, 30 September). In this connection, it was understood that the working group would consult further with WSEG regarding the realism of 1965 as the date for the assumed capabilities. It was also agreed that this be a high-level working group with maximum clearances, under a chairman to be selected by Mr. Dulles, and that the group should attempt to complete its work in about six weeks.

10. Budgetary Discussion

The members discussed certain matters bearing on the method of presenting items for budgetary purposes. It was agreed that the members should study their individual problems, and consult with their comptrollers and with the Bureau of the Budget on a working level, after which the IAC would again review these questions with representatives of the Bureau of the Budget from the standpoint of the manner of presenting any over-all budget for the intelligence community.



a. Watch Committee Report  
No. 376

Noted.

b. Sensitive Situations

The Chairman referred to the recent bombing of US personnel and property in Saigon and General Schow reported various details on the background, circumstances and extent of injuries or damage. Several members expressed the view that the bombings appeared to be Communist-inspired rather than a manifestation of popular anti-US sentiment.

The members discussed a [redacted] purporting to give details regarding US [redacted] of Soviet missile activity. In their discussion the members touched on matters such as possible [redacted] reaction, source and accuracy of the information and remedial measures, including new legislation, that might be taken to prevent or punish adequately such cases of unauthorized disclosures of classified information. General Lewis stated that the Air Force was actively investigating the incident. The Chairman noted that this article had been discussed in high quarters and that he might report on it to the NSC and possibly review the question again with the IAC members.

It was also agreed that copies of the memorandum, as amended, would be distributed to the members on a limited basis.

b. GMIC Report

The members considered a GMIC proposal in restricted session, during which General Cabell presided. The GMIC plan was approved, subject to certain considerations raised during the course of the discussion.
