2. Approval of Minutes

3. Situation Review

a. Watch Committee Report
No. 375

Noted.

b. Sensitive Situations

With respect to the Middle East, the Chairman and members discussed [redacted] report which related to possible Syrian reaction to certain Israeli activity. In connection with the dispatch of Egyptian troops to Syria, Mr. Cumming noted that the State Department had in fact received advance intelligence from various sources over a period of time bearing on this possible development. Several members also referred to the desirability of following developments in Lebanon closely.

The Chairman noted that the recent orbiting of a satellite by the Russians was in consonance with a National Intelligence Estimate,

and that the White House had been so advised.

The Chairman stated that any Yugoslav recognition of East Germany would not come as a surprise to the intelligence community and the members exchanged views on the possible consequences of this move, particularly on the probable reactions of West Germany and various "uncommitted" countries. The Chairman suggested that this be regarded as a sensitive situation to be followed closely.

Mr. Cumming referred to recent developments in East Germany and noted that he considered this a sensitive, though not necessarily critical, situation. He and the members then exchanged views on this situation, especially with regard to the issuance of new currency and the possibility of other East German moves.

4. NSCID No. 7
(IAC-D-105/7, 3 October)

The members discussed this draft NSCID with [] particularly in the light of questions raised by Mr. Cumming, Admiral Frost, Mr. Reichardt and Mr. Roach. Following this exchange of views the draft was preliminarily approved subject to: (a) deletion of "defense" in the eighth line of para. 1; (b) insertion of "and as appropriate" after "possible" in line three of para. 4; and (c) insertion of "academic research information or" after "of" in the seventh line of para. 6.

The members took cognizance of the FBI's reservations and agreed that a proposed DCID be prepared by the appropriate working group and be available for IAC review at the time when the draft of NSCID No. 7 is submitted for final IAC approval.

(IAC-D-105/16, 2 October)


After discussion the members tentatively approved this draft NSCID, subject to the understanding that it would be reconsidered later when all of the NSCID's are reviewed as a group.
