Approved as written. The Chairman also raised a question with respect to release of NIE 100-3-58 to the Business Advisory Council as referred to in item 6 a of IAC-M-355(See item 4 b below).

2. Situation Review

b. Review of Sensitive Situations

The Chairman and members discussed recent developments in the Taiwan Strait situation, particularly with respect to Chinese Communist and Chinese Nationalist aircraft dispositions and activities. In this connection, General Watson informed the members regarding the nature of a study by a group of propaganda appearing in the Chinese Communist press over a certain period of time. The members then discussed in some detail this project and other matters related to the general question of analyzing Bloc propaganda. After exchanging views, the members concurred in the Chairman's suggestion that a preliminary study be made of the kind of work already being done (both within and without the intelligence community) on analysis of Bloc press and radio propaganda.

The members also discussed certain aspects of the Middle East situation, especially the question of internal stability in Jordan and Iraq.



3. Expansion in Activities of
IAC Exchange Committee
(IAC-D-103/7, 8 August)

The members noted a memorandum circulated prior to the meeting (IAC-D-103/7) which incorporated an excerpt from the minutes of the 30 July OCB meeting and outlined possible action by the IAC to meet the OCB requirement. The Chairman stated that he had accepted the OCB minute subject to ratification by the IAC. After discussion, the members agreed (a) that the Exchange Committee should be instructed to expand its activities to include consideration of the intelligence aspect of proposed exchanges of materiel with the Communist Bloc countries, on the understanding that military members of the Committee would apprise the Committee of the views of the Department of Defense when the Committee considers recommendations with respect to items having military significance; and (b) that pertinent information developed by the sub-committee would be supplied to the East-West Contacts Staff of the Department of State.

After discussion (during consideration of the minutes of last week's meeting, as noted in item 1 above) the members concurred in the Chairman's suggestion that three copies of NIE 100-3-58 be released to the Business Advisory Council for use in the course of their current study of the Soviet trade and aid offensive. It was also understood that a very limited number of additional copies might be made available for use in connection with a specific briefing or meeting of Council members, provided that any such copies are kept under the strict control of authorized CIA or State Department personnel while being so used, and are returned to the normal intelligence storage areas after use.


Mr. Cumming advised the members that he had been asked by the State Department to request the initiation of a special estimate on the Saudi Arabian situation.






