MEMORANDUM FOR: DEPUTY DIRECTOR

SUBJECT: IAC Meeting Thursday, 4 January 1951 at 1100 hours

1. Approval of Minutes of meeting 28 December 1950 (IAC-M-12).
2. Assistance to the VOA and Other Aspects of Soviet Jamming (IAC-D-11) - Mr. Armstrong
 - a. As a member of USCIB you have approved this report.
 - b. It is important that someone get ahead with the VOA support and despite USCIB's weaknesses it is the best we have at the moment to coordinate and push ahead on this business.
 - c. The whole problem involved in USCIB has got to be gone into and that is being worked on by O/SS.

The other questions relating to this subject which were not referred to the USCIB but which should be included in any report to the NSC are encompassed in IAC-D-11/1. It is recommended that D-11/1 be approved and transmitted to the NSC with the USCIB Report which covers one aspect of the total problem. Proposed CIA revisions have been distributed at this meeting and [] (Deputy Assistant Director, SI) can explain them.


