I have your letter of May 5th proposing the development of an agreed estimate on the threat to North America by the [redacted] U. S. Intelligence Advisory Committee. This matter has been under earnest consideration by myself and my colleagues on the Intelligence Advisory Committee and is also under study in the U. S. Department of Defense.

There is no question in our minds as to the desirability of our [redacted] reaching agreement to the maximum extent possible on the nature and magnitude of the threat that NORAD has been established to meet. At the same time it seems clear that the terms of reference to be given the estimators of [redacted] must come to them through appropriate command channels. This requires agreement in principle and development of procedures [redacted]

I am, therefore, prepared now to state that the Intelligence Advisory Committee stands ready to do its part toward the production of such an agreed estimate. I have so communicated with the Secretary of Defense, furnishing him with copies of our correspondence in order that necessary action to perfect the required procedures may be taken.

In order to get forward as rapidly as possible with the accomplishment of this exercise, we have been engaged in a review of all the evidence bearing on Soviet heavy bomber and long-range guided missile programs and should have our revised estimate in suitable form for exchange with you early next month. I am hopeful that
