SecDef has approved, and directed implementation of, JCS measures designed to strengthen the intelligence authority and capability of the unified and specified commands, and designation of DIA as the primary JCS agent to support and provide guidance and direction to those commands in intelligence matters.	Indefinite
(4) Require JCS to coordinate activities of unified and specified commands and be the primary channel for guidance and direction on intelligence matters originating within DOD.	SecDef has approved, and directed implementation of, JCS measures establishing DIA as the JCS agent for providing intelligence collection requirements, guidance and direction, to the unified and specified commander, who in turn will establish plans, policies and over-all requirements for the intelligence activities of his command, and direct and coordinate the intelligence requirements and collection activities of his command.
