Concerning: (Dr. Med.) Miklós CSOMOSS, born 8.3.1898

Subject fled to Austria on 30 November 1956 from Hungary. On 22 December 1956 he went illegally again to Hungary, reportedly to bring his wife and daughter to Hungary. According to his statement he discovered the end of April 1957 that he was to be arrested and therefore fled alone again to Austria on 30 April 1957.

According to confidential information, he is described as a questionable character. He was said to have been arrested by the Soviets in Hungary in 1947 because of intelligence activity for the West, to have been released later, to gather information for the Soviets. Further it was important for him in the end of September 1956 to leave Hungary again, while he himself said it was necessary for him to flee to Austria in April 1957. It is also interesting that his wife and daughter after his flight to Austria, received ~~xxx~~ visas to visit Yugoslavia. His sister-in-law is rumored to have been allowed take possession of his apartment in Budapest, although no furniture was removed from this apartment.

Dr. CSOMOSS makes many trips out of Austria to other western countries and he attends many meetings of Hungarian Freedom fighters.
