JONAS DAINAUSKAS

The visa files of the U. S. Embassy, Paris, France, reflect that JONAS DAINAUSKAS, born January 21, 1904, at Kaunas, Lithuania, residing at 6 Cite Joli, Paris 11, France, has applied for an immigration visa to enter the United States.

The visa file reflects that DAINAUSKAS entered France from Poland in January 1957. He held Polish passport No. CA 001489.

His file reflects the following residences:

- 7/44 - 8/44 refugee from Lithuanian border with a group of refugees
- 8/44 - 9/44 Stralsund German Air Force (Unity) Regiment Barracks and Hoya/weser (south of Bremen) German Air Force Regiment as "Kampfhelfer"
- 10/44 - 2/15/45 In Polish prison at Poznan, Poland, as politically unreliable for Polish Communists
- 2/45 - 12/2/45 In USSR concentration camp at Poznan as being politically unreliable
- 12/45 - 2/51 Various towns in Poland
- 2/51 - 1/57 Poznan, ul Stogowaka 20/1

He indicated that he escaped from the Russian concentration camp at Poznan and in Poland was able to disguise his true nationality and integrate himself into the Polish community. He obtained a position in the Agrarian Reform Bureau as a clerk. He joined the Polish Workers Party (Polish Communist Party) in December 1947 for fear of deportation to Russia. He was a member until December 1956.

His parents were NATAN and PEDRONELLA DAINAUSKAS. His occupation was listed as jurist-economist. He indicated that he has a sister and brother in Lithuania.

Subject's wife was listed as Mrs. LEOKADIJA DAINAUSKAS, a nurse, employed at St. Mary of Nazareth Hospital, 1120 North Leavitt Street, Chicago, Illinois. She and her daughter, also a nurse at the same hospital, reside at 4355 South Rockwell Street, Chicago.

His wife arrived in the United States at New Orleans, Louisiana, aboard the SS General Taylor on April 6, 1949. She became a U. S. citizen at the U. S. District Court of Omaha, Nebraska, on November 23, 1951 (Certificate No. 7256180). They were married on December 25, 1928, at Kaunas, Lithuania. She listed \$3,143.41 in the Talman Federal Savings.

His daughter is JURATE DAINAUSKAS, and his son is JOHN RIMOYDAS DAINAUSKAS, born December 9, 1930, in Lithuania, who was in the U. S. Army (Serial No. RA 17 377 527) and is presently attending Loyola University.

The Department of State has been requested to furnish an advisory opinion regarding DAINAUSKAS' visa application.
