1. Attached are Headquarters' traces on the individuals mentioned in Reference A with the exception of GUNNY traces, which are being handled separately per Reference C, paragraph 1. These traces may be passed to UPSWING. Our basic information on these individuals does not add substantially to what UPSWING already knows.

2. With one exception, we do not foresee that UPSWING's possible operational interest in C (the correct cryptonym of the person you refer to as C) will particularly threaten our operations. The exception is C, who must make his living in West Germany, and whom UPSWING already suspects of AIS connections. We prefer not to confirm UPSWING's suspicions, but, should it be impossible or pointless to deny our contact with C, we suggest that you inform UPSWING that we maintain occasional contact for the purpose of getting information on the activities of the Lithuanian emigration.

3. We would like clarification of your opinion of the nature of UPSWING operational interest in the persons, other than DAINAUSKAS, on whom traces are requested in Reference A. Are the operational leads mentioned in MUNI 5700, paragraph 1, OS leads in connection with UPSWING's investigation of DAINAUSKAS? Or do you think UPSWING is interested in the leads for other possible exploitation?

6. Mrs. NAVAKIENE, nee DEVEIKYTE - No traces.
 - a. Jonas NAVAKAS - No identifiable traces.
 - b. Vytautas DEVEIKIS - No pertinent information. MUNI #6794 cites a DEVEIKIS that may be the same as Subject.
7. P. PAMATAITIS.
 - a. A report dated 20 September 1950 gives the following biographic data on a person who appears to be identical with Subject:

Petras Gustavas PAMATAITIS (sic)
born 18 January 1900 in Kuprine, Sakiai, Lithuania
Address: 7647 Mulholland Drive
Los Angeles, California
Wife: Elvyra PAMATAITIS
Was chief of Criminal Police in Lithuania from 1932-40 and
from 1941-44.
Entered New York on 30 May 1949.
 - b. A report dated 1 May 1956 states that a Dr. Petras PAMATAITIS, representing the Resistentininkai (pro-Lozoraitis group), participated in negotiations with the Frontininkai (the Lithuanian Front under the leadership of Jozas BRAZAITIS) to join the Supreme Committee for the Liberation of Lithuania (VLIK).
8. [] - is currently living in California. We have no information in our files of the connection between him and DAINAUSKAS.
9. Vaelovas SIDZIKAUSKAS, born 10 April 1893 in southern Lithuania. He is currently chairman of the Lithuanian delegation to the Assembly of Captive European Nations and president of the Committee for a Free Lithuania. He is also a member of the Plenum of the Supreme Committee for the Liberation of Lithuania, which has offices in both New York and Germany. Our files contain no derogatory information.
10. Jurgis VALIULIS, aka Karolis DRUNGA - Headquarters traces do not add to what is already known by MOB and UPSWING.
11. [] - No new information since your last talks with UPSWING about him.
12. Mrs. WILZ - No identifiable traces.

- A. Jonas DAINAUSKAS - No additional traces other than ODEWY traces which are being handled separately. Otherwise Headquarters traces add nothing to what is already known by UPSWING.
- B. 1. Leokadija DAINAUSKAS - No additional information except ODEWY material. An ODOPAL file on Subject contains no derogatory information.
- 2. Pranas DAINAUSKAS - No traces.
- 3. Elena DAINAUSKAS - No additional information.
- 4. Rimvydas-Jonas DAINAUSKAS - An ODOPAL file contains no derogatory information.
- 5. Jurade-Leokadija DAINAUSKAS - No additional information.
- C. 1. Stasys Antanas ~~BACKIS~~ BACKIS, born 10 February 1906. Subject is Charge d'Affaires of the Lithuanian Legation in Paris, chairman of the Lithuanian Community in France, editor of Bulletin Lithuanien, and is connected with the Free Europe University in exile. There is no derogatory information in Headquarters files.
- 2. [] - See covering dispatch.
- 3. K. V. GRINIUS - Probably identical with Kazys Vincas GRINIUS, born 8 September 1899 at Pilviskiai, Suwalki, Lithuania; was a Lithuanian citizen until 1942; came to the United States in 1941; from 1924-27 lived in Brussels, where he attended the General Staff Academy; from 1927 to 1935 he lived in Kaunas; from 1935-41 Lithuanian Military Attache in Berlin; His military service covered the years 1918-40 and he was a member of the Lithuanian General Staff. In 1952 he was Chairman of the Lithuanian National Council in the United States. He is reported to have been employed by one of the German intelligence services after the Soviet occupation of Lithuania. Employment in the United States has included Voice of America and Syracuse University. Wife: Marija Grazina. Son: Algis - born 1927.
- 5. Simas MIGLINAS - At present time he is employed as a writer by the Supreme Committee for the Liberation of Lithuania (VLIK) in Reutlingen. UPSWING undoubtedly has a much more complete file on him than we have.
