On September 22, 1970, CG T-1 advised that there appeared an article in "Vilnis", Lithuanian-language newspaper published on that date on page 1, column 5, that Vytautas Zenkevicius (Vitautas Zenkevichyus) arrived in New York. This article stated that well known to American Lithuanians, Zenkevicius, who for many years was employed in secretarial duties at the Soviet Embassy, Washington, D.C., had returned to New York City as a delegate to the Soviet Mission to the United Nations (UN), in New York City. The article mentioned further that Zenkevicius has many acquaintances and friends in America. It is difficult to say whether he will have time to visit with them.

It is noted the article had a by-line "New York."

The "Vilnis" has been designated by the Committee on Un-American Activities, the U.S. House of Representatives, Washington, D.C., to be a Communist, Lithuanian-language newspaper.

CG T-1 advised that Zenkevichyus had previously been assigned as Second Secretary of the Soviet Embassy, Washington, D.C., for about six years but had departed the United States for the U.S.S.R. in September, 1968.

On October 2, 1971, CG T-2 advised that Vytautas Zenkevicius is associated with the "Ministry for Foreign Affairs of the Lithuanian Soviet Socialist Republic" and






