1. An extensive search of the files and indices of the Directorate of Operations surfaced no record of Janis Sukans and Juris Krisjanis.

2. A State Department Refugee Relief Program name check was submitted on 14 July 1955 for Mathias Giesi Denuel. The document is attached for IMS/LSS review. In response, State Department was referred to the Department of the Army.

3. The following is the verbatim text of a Counter Intelligence Corps report concerning Matthias Denuel:

"On 18 October 1955, the records of CIC/CF, Fort Holabird, Maryland, were searched in the name of Subject and the following information was revealed:

Dachau Detachment, War Crimes Group, JA Division, United States Forces, Europe Security Section, Army Post Office 203, Document, dated 24 September 1945, Subject: Identification of Prisoners, reveals the name of Matthias _____, War Crimes Cage, PWE 22, Drachau, Romanian (Volksdeutschen), born 12 February 1920, at Bulgarus, Rumania, Former Residence: Number 378, Bulgarus, Rumania. Member: Waffen SS 01 August 1943 to May 1945.

Subject was a guard and tailor at the Gusen Concentration Camp from 10 August 1943 to 14 April 1945. He held the rank of Corporal in the SS Totenk, 511 Stuba Mauthausen. From April 1945 until May he served with the Combat Group Oberdonau.

A Status Report, Headquarters First Division, Civilian Interment Camp #9, dated 04 August 1947, Subject released on 24 July 1947, as not affected by the Nuremberg Trial, previously detained at dachau-Hammelburg.

No additional information in the name of Subject is available at this source." End of Report
