

MEMORANDUM

SUBJECT:

1. Reference is made etc. . . .The files contain voluminous information concerning one Dr. (lawyer) Joachim DAEUMLING (alias DEUMLING, Hamei DAUMLING) born 1910, Begerhof Germany, Advisor to Egyptian Army Intelligence Directory in 1954, who is believed to be identifiable with the subject of your request.

A summation of the information is as follows.

2. Reports from fairly reliable sources indicate that DAEUMLING, a highly educated man with a doctor's degree in law, entered the SD (Security and Intelligence Service of the Nazi Party in December 1936; Appointed Ostuf. in September 1938; MESA (Main office State Security and Nazi Party) in July 1942; SIPO and SD Esseg (Yugoslavia) in March 1944; 1944/45 officer in Section IV (Gestapo) of RSHA.

3. Reports indicate that DAEUMLING arrived in Egypt in 1954, as Intelligence Advisor to the Directory of Military Intelligence, Egyptian Army. Curiously, both DAEUMLING and the Egyptians took the utmost precaution to keep his arrival secret. ~~Indeed~~ So great was DAEUMLING's desire for caution, (according to a report from a usually reliable source whose information is possibly true) that

instead of flying directly to Egypt from Germany, DAEUMLING traveled to Zurich by train, and took a plane to Egypt from there. Throughout this trip, according to source, DAEUMLING went to great pains to keep his name from becoming known to any travel agency, ticket office, or hotel management. His alleged reason for this was that he wished to avoid the attention of British occupation authorities in Germany.

4. Reports further indicated that DAEUMLING, who was brought to Egypt by Wilhelm VOSS, head of the German Advisory Group, differed from his predecessor

EGP-27 experts in that he, DAEUMLING was active in the collection and evaluation of information, whereas his predecessors' functions were ~~mostly~~ confined to an advisory or organization and training capacity.

5. DAEUMLING was reported as having no contact with the remaining German Experts in Egypt (General FARMBACHER Group). His activities were severed from this group and kept secret. In his efforts to camouflage his real activities, DAEUMLING was reported on different occasions to have mentioned that he was doing statistical work at the Ministry of Health, or that he worked for the Ministry of Social Affairs.

6. A report dated October 1954, from a usually reliable source whose information

is possibly true, indicated that after his arrival in Egypt, DAEUMLING concerned himself with the interpretation of International law, and translations. But

7. A report dated July 1954, from a usually reliable source suggests the ~~belief~~ possibility that DAEUMLING would not be able to complete his assignment in Egypt alone, and was expected to call upon his friend from the RSHA, Dr.

9. Daeumling's name was mentioned in Yugoslav Black Book (March 1954) as being an SS man, State Prosecutor and having been in OS, CH during WWII
