Practiced law and joined SITPO only a few years ago. Promoted to O.c. Abteilung IV D2 in RSHA (Section of STAFG dealing with SITPO in General gouvernement). Was removed from office in the Spring of 1943, probably because of his share in negotiations with Polish leaders, and transferred to a SITPO Einsatzkommando near Esseg, Croatia. Merz states that Deumling is only a luke warm Nazi. Merz served under him in IV D 2 from Jan -May 42 and continued to collaborate with him until beginning 1943.
