<p>14.</p> <p>DEVA, KHAFER [ ]</p> <p>AN OPINION WAS REQUESTED FROM SUBJ WHO IS NOW IN CHARGE OF THE FISCAL UNIT AT STANFORD UNIV, PALO ALTO, CALIFORNIA. DEVA FORMERLY LIVED IN KOSOVA AND WAS FROM A WEALTHY FAMILY AND HE EVENTUALLY OWNED A LARGE LUMBER MILL IN THE EXTREME NORTHERN PART OF KOSOVA. HE WAS EDUCATED AT ROBERTS COLLEGE IN ISTANBUL, TURKEY, AND RECEIVED ADDITIONAL EDUCATION IN LONDON, ENGLAND. LATER HE WENT BACK TO KOSOVA AND OPERATED THE LUMBER MILL. ABOUT TEN YRS AGO DEVA WAS USED BY THE UNITED STATES GOVT. IN TRAINING ALBANIANS FOR A MISSION INTO ALBANIA. DEVA IS ABOUT 55 YRS OLD AND HAS BEEN IN THE UNITED STATES SINCE 1956. HE SPEAKS FIVE LANGUAGES FLUENTLY AND IS A VERY CAPABLE MAN.</p> <p>DEVA ADVISED IN RESPONSE TO A REQUEST FOR HIS OPINION, THAT BECAUSE OF HIS JOB AT STANFORD UNIV, HE COULD NOT TAKE THE TIME TO PERSONALLY GET INVOLVED IN ANY KOSOVIAN GROUP, SUCH AS WAS PROPOSED. HE OPINED THAT ANY ORG WHICH HAD AS A GOAL TO TAKE ACTION AGAINST YUGOSLAVIA IN CONNECTION WITH KOSOVA, WOULD BE DOING A DISERVICE TO THE KOSOVIAN PEOPLE. HE POINTED OUT THAT COMPARATIVELY SPEAKING, THE KOSOVIANS ARE ENJOYING MUCH GREATER FREEDOM THAN ALBANIANS IN ALBANIA, AND THAT EVEN THOUGH THEY ARE UNDER A COMMIE RULE, THEY ARE MUCH BETTER OFF THAN ARE OTHER PEOPLES BEHIND THE IRON CURTAIN.</p> <p>HE SAID THAT ANY GROUP WHICH ANTAGONIZED TITO OR THE SERBS WOULD LIKELY TO BE CAUSE OF FREEDOMS BEING TAKEN AWAY FROM THE PEOPLE. HE SAID THAT HE WOULD SUGGEST THAT SUCH A GROUP MAKE A DETAILED STUDY OF THE SITUATION IN KOSOVA; ORDER NEWSPAPERS AND MAGAZINES FROM KOSOVA; TALK TO RECENT VISITORS AND EMIGRES, AND OTHERWISE FIND OUT THE TRUTH ABOUT KOSOVA BEFORE LAYING ANY PLANS TO ATTACK THE PRESENT KOSOVIAN STRUCTURE.</p> <p>DEVA SAID THAT HE WOULD FAVOR A GROUP BEING FORMED PURELY AS A SOCIETY AND/OR CULTURAL GROUP AND WHICH ADHERES TO A NEUTRAL POSITION REGARDING ALBANIAN POLITICAL PARTIES. HE SAID THAT HE FAVORS THE IDEOLOGY OF A FREE KOSOVA, ETHNICALLY UNITED WITH A FREE ALBANIA BUT THAT ASIDE FROM BEING READY TO TAKE WHATEVER ACTION IS NECESSARY AT ANY GIVEN TIME, HE DOES NOT BELIEVE IN PROPAGANDISTIC ATTACKS AGAINST YUGOSLAVIA.</p>
