SUBJECT: POB Traces on DICKKOPF, Paul, born 9 June 1910 in Mueschenbach/Oberwesterwald  
MGLA-10538, 27 Feb 52: Included in its attachments copy of a report from the GEHLEN  
 Org. to the BfV concerning Subject. The report is evaluated C-3. In the BKA  
 DICKKOPF is said to work as a sort of personal assistant ~~SECRETARY~~  
 to Geheimrat Dr. HAGEMANN. Available information indicates that Subject completed  
 his criminal police training in Frankfurt in 1939. He was employed as a Kriminal  
 Kommissar. In 40 or 41 he was with the criminal police in Frankfurt. He apparently  
 a member of  
 passed himself off as/the secret field police and attempted to obtain ~~in~~ Belgian  
 an trip  
 passports. Allegations have been made that during ~~the~~/official/to France in 1942  
 he deserted and joined the French resistance movement. He is alleged to have  $\phi$   
 attained the rank of Capt. or Maj. in the French Forces. It is further alleged  
 that during the war Subject at a time which cannot be precisely defined worked as  
 liaison between the police hqs. in Karlsruhe and the Abwehr in Stuttgart. In 1949  
 he appeared in the Frankfurt police office and established contact with the then  
 chief ~~THE~~ FRIES (?). DICKKOPF stated that at that time he was working for the  
 Americans and frequently had occasion ~~had~~ to fly to Berlin to perform important  
 secret service ~~secret~~ missions, Besides which, he claimed that in 1941 he had fled  
 Zurich,  
~~the~~ Switzerland, because at that time he was engaged in intelligence activities.
