1. Paragraph 4 reference requests information on procedures necessary to obtain the services of [] for CARAVEL's organization. We have discussed the problem with several offices here, and after having been informed of several programs possible, believe that you may wish to study the material which we have been given, to enable you to decide which of the special programs may best fit the needs of the CARAVEL organization. Under separate cover we are forwarding a brochure which briefly explains the [] organization and should provide you with background for possible discussion with any interested parties.

2. [] has recently become interested in assistance programs for organizations such as that to which CARAVEL belongs. Under separate cover we are also forwarding data on this "1290-d Program". As a matter of interest, several surveys on CARAVEL-type organizations in various countries have recently been completed under sponsorship of [] Studies on other countries are being carried out or planned. We are informed, however, that the study for Germany will be one of the very last and probably will not be undertaken for a year or so.

3. We do not know how much information on the [] program is currently available in Germany, but suggest that after reading the separate enclosures you may wish to check with the local [] representative to determine if sponsorship of services desired might best be handled through and by []
