TOYKA AND UNKNOWN FORNOFF OFFICIAL AGREED ODYOKE MUST BE CONSULTED. SINCE CARAVEL MET NO RESISTANCE TO PROSPECT CUBA VISIT, HE ADOPTED COMPLETELY NEUTRAL ATTITUDE.

2. PRESUME FORNOFF WILL CONTACT ODACID BONN 16 SEPTEMBER. NO RESPONSE TO BE GIVEN TO CUBAN PHONE INVITATION CITED FROB 7723 (IN 10213) UNTIL ODYOKE CONSULTED. REQUEST BONN ADVISE ANY DETAILS LEARNED FROM ODACID BY 19 SEPTEMBER, WHEN PLAN ANOTHER MEET WITH CARAVEL TO LEARN RESULTS CONSULTATION AND FEDREP GOVT DECISION. CARAVEL TRAVELS TO BREMERHAVEN 21 SEPTEMBER.

3. DIR: FAIL UNDERSTAND PARA 2: REF. RE PARA 3 REF CARAVEL ADVISED CONTACT ARRANGEMENTS AND PER DIEM. UNCLEAR IF CONTACT WITH KUBARK IS TO BE OVERT OR COVERT. PLEASE CLARIFY. HAVE INSTRUCTED CARAVEL MAKE CALL FROM PHONE BOOTH ANYWAY, NOT THROUGH HOTEL SWITCHBOARD.
