1. REQUEST STATION CONTACT CARAVEL AND OBTAIN HIS INFORMAL COMMENTS RE FEASIBILITY OF UTILIZING INTERPOL AS CENTRAL COORDINATING AGENCY TO COMBAT SKYJACKING. HQS PARTICULARLY INTERESTED IN CARAVEL OPINION RE BOTH POLITICAL AND TECHNICAL PROBLEMS IN CONNECTION WITH UTILIZATION OF INTERPOL FOR THIS PURPOSE. ESSENTIALLY IT IS DESIRED THAT A CENTRAL CLEARING HOUSE BE ESTABLISHED FOR ALL DATA CONCERNING:

- A) SUSPECT PERSONALITIES AND TECHNIQUES UTILIZED BY SKYJACKERS.
- B) HIGH SPEED COMMUNICATIONS FACILITIES TO ALL AFFECTED AREAS.
