4. (C/NFD) Item 36: Spent a vacation at an unknown place in ITALY during the Easter Holidays, 8-12 April 1971. It is not known if he was accompanied by some or all members of his family.
5. (C/NFD) Item 38: DICKTEN enjoys the complete confidence of the Commanding General, BGS Kommando Sued. DICKTEN's reassignment from the Federal Ministry of the Interior, BONN, to his current position was arranged by the current CG of Kommando Sued. Several promises of promotion to LTC either in the current position or in another assignment within the Kommando Sued failed to materialize, thus straining relations somewhat between the CG and DICKTEN. After it became obvious that DICKTEN could not be promoted in his current position due to TOE limitations, DICKTEN began to insist on other assignments for which he was in line and could qualify. In order to clear the way for a promotion to the rank of LTC, DICKTEN is now scheduled for reassignment o/a 15 August 1971, from his present position to assume the command of the BGS 4th Battalion, 2d Regiment, in COBURG, FRG. This will be his first assignment to command a unit. There are indications that later he may return to the BGS Kommando Sued, in MUNICH, to take over the position of G-3. The reassignment will cause DICKTEN family to be separated for a time. There are indications that his wife and a baby son will remain behind at the current address, and there are also some indications that the daughter, Sabine, may join her father in COBURG.
6. (U) Item 43: First name of Wife: Gerda.
7. (C/NFD) Item 50: Daughter, Sabine, was Confirmed on Whitsuntide 1971, in MUNICH, FRG. She studied the English language in school for the past five years and speaks it fairly fluently, often acting as an interpreter for her father. She discontinued English courses in school, and has started with the French language which she now likes better.
8. (U) Item 52: Religion: Evangelical.
