Discussion of 19 June 1947 regarding [] and []

REF: ECBA-4120, et seq *see CHBANK*

1. In a session lasting the entire afternoon of 19 June, UPSWING representatives, G. WUNDER and G. BEZZ, were briefed by [] and [] with [] and [] in attendance regarding certain operational leads provided by [] and [] which we had either attempted to exploit or had investigated and trace down the persons concerned to the point where operational exploitation could now be undertaken. UPSWING was informed that [] and [] had been instructed to leave the coordination of these cases to us, inasmuch as many of these leads were unresolved and investigations were under way at the time [] and [] were turned over to UPSWING - a turnover we did not feel should be delayed. He covered every operational lead and operational maneuver we made involving [] and [] in a rather intense and furious verbal briefing which G. BEZZ presumably was able to reconstruct, as he took notes at a frantic pace throughout the afternoon. Attached herewith, in form suitable for passing directly to UPSWING and with an extra copy for retention of Pullach, is a brief summary of each of these operational cases, indicating the persons involved, the action taken by us, and the agreement we understand to have been reached with UPSWING with respect to future pursuit of the lead. Also included is a brief summary of the infiltration of [] family, and the status of negotiations regarding [] family. It is again noted for the record that the family status of [] and our efforts to infiltrate these families, were clearly indicated to UPSWING during my

Three discussion of the proposed turnover of [redacted] to [redacted]. The subsequent arrest of [redacted] could not have been known to us at that time, but in general I think it is a fair statement that [redacted] was given at least a verbal briefing on the various security ramifications and difficulties of this case before they accepted custody.

2. The turnover of [redacted] and [redacted] to [redacted] has been, I think, an instructive experience. Discussion with [redacted] staff officers concerned the handling of [redacted] quite different viewpoints. Our original approach, and this turnover from quite different viewpoints. Our original approach, and one to which we eventually adhered, consisted more or less bringing [redacted] into the exploitation of these defectors on a joint basis - asking of them in return only assistance in securing the [redacted] from our association with [redacted] and [redacted] from our association with [redacted] and [redacted] we felt very strongly that neither should be considered, even for a moment, for continued employment in the intelligence field, and this was expressed by [redacted] (no [redacted] during the March discussion; it becomes clear from the subsequent history that [redacted] desired to [redacted] own conclusions and if possible achieve a position with [redacted] permitting their unilateral exploitation of any leads they secured so to pursue. Undoubtedly the [redacted] objective, which was clearly understood by [redacted] is the normal reaction of an independent service and the basis upon which we should probably in the future plan any such turnover. In short, then, the physical turnover of any body should undoubtedly be clean and predicated upon a total break of relationship with the person or persons turned over, leaving all future exploitation and negotiation with said person to [redacted] (or the service involved). If we desire to withhold certain leads and maintain certain operational equilibria, we have little choice but to endeavor on our own to reestablish such a defector; even though [redacted] or [redacted] will locate such a reestablished source, we are under no obligation to either of these officers to reimburse our operational equity or inform them of our exploitation under these circumstances.

3. The further point made clear by the turnover of [redacted] and [redacted] is that [redacted] should have a "refinement" who has facilitated himself with all aspects of our exploitation of the defector being turned over. It can be learned without difficulty, I think, that an association on an all-day and half-the-night basis over a period of two months with an [redacted] does not admit of full and complete documentation on a current basis; inevitably the various interrogators' names notes on the basis of which they re-interrogate and exchange views with other interrogators, out of which ultimately comes the interrogation report. Concurrently, operational exploitation is under way and innumerable contact reports are building up regarding operational moves. In the instant case, five [redacted] staff officers and [redacted] interrogated

[] and [] and pursued leads they provided during the period early January to the end of March. A completely collected account of all this activity still does not exist; rather individual files of operational leads are at hand at BOB, and the final interrogation reports are now being completed. With these practical considerations, it was agreed between FOB and BOB that a smooth turnover could only be achieved in such a case by sending a FOB officer to Berlin to discuss with all concerned the status of exploitation of any such defector, and to reach an agreed position with BOB regarding the scope of statements and/or reports we would provide to UPWARD in conjunction with the turnover.

4. Despite all the problems we (and UPWARD) have had regarding this case, it is our impression from conversation with G HORNBERG and G BEYZ that we have nonetheless achieved our objective in the turnover of these defectors. G BEYZ indicated very clearly, and even G HORNBERG was forced to agree, that [] and [] had provided UPWARD with a totally different concept of the role of the Kreis Dienststelle of the NKS, which G BEYZ assessed to be valid and worth all the difficulty [] and [] have represented. In addition, G HORNBERG indicated that UPWARD has ceased operational exploitation of [] and [] until this time, preferring first to establish them in a new life (with which we most heartily agreed) but, having now accomplished this, G HORNBERG anticipated that he would shortly be presenting to the FOB staff certain operational proposals for discussion and joint consideration. If this in fact comes to pass, we should indeed achieve our objective of getting together with UPWARD on the NKS problem.

5. Undoubtedly the brightest spot of the afternoon was the brief discussion with G BEYZ regarding NKS operations and modus operandi. G BEYZ strikes us as an unusually enthusiastic, straightforward, and intelligent person with whom we expect to have regular interesting exchanges regarding the NKS.

PROTOCOL OF MEETING HELD AT 121C ON 19 JUNE 1947

1. As we understand it, Otto and Heinz now have their West German identification papers, and Otto and his family have housing. As for Heinz, his housing problem, not yet a difficult one since he has not yet been joined by his family, should be solved in the near future.
2. In the matter of Heinz's family, it was explained that we were in contact with his sister-in-law Frau ECKARD, born circa 1931, living at Pippach-Edelhausen bei Weimar. Through ECKARD we succeeded in transmitting to his wife's lawyer the necessary funds to cover legal fees and restoration of the embezzled monies charged against his wife. At our last meeting with ECKARD, we learned that his wife was still being held in investigatory custody, but that her release should be imminent. However, because of the successful evacuation of Otto's family to West Berlin and the ensuing MRS investigation resulting in at least one arrest, it was learned that ECKARD had also been questioned by the MRS. She failed to appear at a meeting arranged for late May, alternate for early June. Since that time Heinz has passed from our control, and we have lost the means of pursuing the evacuation of Heinz's wife and infant son. We are willing to continue to act in this matter, withdraw from participation, or support a joint effort. However, in view of the security dangers in Weimar at the present, we feel that no action should be taken for a few months, at least.
3. In the case of Otto, we passed you a photocopy of a letter apparently written by his ex-girl friend Karin LORENZ, born circa 1938, living at Weimar, Platz der Deutsch-Sowjetischen Freundschaft 1, bei GABE, to Otto in care of a fictional name at the address of the KGB. It was explained that this may well be an MRS attempt to determine Otto's location in West Germany, since LORENZ was involved in the Egon KREIBITZER affair (see attached summary of this case). Inasmuch as Otto was very close to LORENZ, and at one time was considering divorcing his wife in order to marry her, the security threat she presented to future operations involving Otto was stressed.
4. We understand that operational interviews of Otto and Heinz have not yet begun, but will be undertaken after Otto and Heinz have settled down with employment. We reiterated that, concerning termination settlements with Otto and Heinz, we promised only that they would receive housing, a little money to tide them over until they had steady employment, and assistance in obtaining work.
5. Inasmuch as we turned over Otto and Heinz while we were still in operation, or initiating several operations, it was necessary for us to brief Otto and Heinz that we would take up these cases with the appropriate authorities personally. Summaries of these cases (thirteen in number) are attached.

Persons Involved:

1. Horst MAYER, born 1925, Weimar-Ehringsdorf, living at Weimar-Ehringsdorf, Weimarische Str. 24/1
2. Horst LANGE, born circa 1926, living in Weimar, employed at LDP Weimar Kreisleitung

Developments:

We attempted making contact with MAYER through a letter written by KRAUS, which was delivered to MAYER at his home address in February 1957. MAYER did not appear at the suggested meeting site, and shortly thereafter we received provocative material in the letterdrop given MAYER for communicating with us. It appears MAYER surrendered the letter to the NCS, perhaps fearing it an NCS provocation. We are now attempting to make contact with MAYER through his close friend LANGE.

Future Handling:

It was agreed that we would continue to pursue this case unilaterally for the present - traces, if available, would be helpful.

Persons Involved:

1. Kurt SEIDER, alias MOELDER, born circa 1931, living in Weimar, Friedrich Engels Ring 14b (?), photographer at the Soviet Officers' Club, Weimartalle
2. Heinz, personal data known

Developments:

We are planning an approach to SEIDER in the very near future. According to STOLZE, SEIDER has a vacillating attitude toward the DOR, and would be susceptible to recruitment. He had been recruited by the M'S under coercion.

Future Handling:

It was agreed that we would pursue this case unilaterally, disseminating essential M'S information when received.

4. Subject: Bruno Wilhelm Richard ~~Witz~~ KLENN, ex-RIS Weimar secret informant

Persons Involved:

1. Bruno KLENN, born 18 December 1904, Weimar, formerly living at Weimar, Etterburger Str. 104A, owner of an automotive repair shop in Weimar, fled to West Germany in August, 1956, now living at Budecheln refugee camp near Frankfurt/Main.
2. Otto, personal data known

Developments:

Prior to his flight from the DDR, KLENN, who was a Soviet informant, became involved in a black market investigation involving Soviet army personnel. Otto, through his connections with Soviet officers, learned of KLENN's imminent arrest and warned him to flee. It appears the Soviets regard KLENN's participation in the proceedings to be of great importance, for we have detected attempts on the part of individuals in Weimar to lure KLENN back to the DDR. His family continues to live there, protecting his financial and property interests. We are presently in contact with KLENN and will provide a report as soon as there are any new developments.

Action Handling:

It was agreed that we would pursue this case unilaterally for the present, keeping you advised of the status.

Persons Involved:

1. Erich DAUBERT, born 24 January 1920, Pausa, living at Weimar, Deallstadstr 42, employed as Dozent at the Hochschule fuer Architektur, Weimar
2. Heinz, personal data known

Developments:

According to statements by Heinz, DAUBERT was investigated by NCS Weimar in preparation for recruitment by NCS Erfurt Dept XV as a secret informant. We have made contact with DAUBERT under a cover contact, and have established that his activities on behalf of Dept XV, if he was in fact recruited, appear to take place in countries other than the Federal Republic, we having spotted travel to both France and England, but no evidence of travel in the Federal Republic.

Future Handling:

It was agreed that we would pursue this case unilaterally. Traces from Central Files would be provided.

3. Subject: Karl Hilmar HEBECKE, considered for recruitment by M'S Weiser as a secret informant

Persons Involved:

1. Karl Hilmar HEBECKE, born 20 Januar, 1913, Kassel, living at Kassel, Marienstr 24, Hinterhaus/III, presently unemployed
2. Otto, personal data known

Developments:

According to statements by Otto, HEBECKE was to have been recruited by M'S Weiser during the spring of 1937. One of our investigators has approached HEBECKE under the cover of an M'S agent, and HEBECKE has admitted connections with M'S Erfurt. A complete report on HEBECKE's contacts and activities should be available within a few weeks.

Future Handling:

It was agreed that we would pursue this case unilaterally, disseminating eventual M'S information when received.

6. Subject: Rudolf HESCHMANN, N'S Erfurt Secret Collaborator

Persons Involved:

1. Rudolf HESCHMANN (also known as ^{aka} HESCHMANN or ^{aka} HESCHMANN), cover name JULIUS, (born 12 April 1910, living at Weimar, Belvedere Allee 10 D)
2. Ernst ZIEBNER, born 21 August 1914, Frankfurt/Main, living at Frankfurt/Main, Schenckstr 42, employed at the Heiburg-Bremer Feuerversicherungs Gesellschaft, Frankfurt/Main, Rheinstr. 24
3. (Graf) Johann Adolf Von KIRLMANSEGG, personal data known
4. Werner DIEBRICH, born 4 June 1912, Engelsdorf bei Leipzig, permanent address at Volkach (near Weisburg), Ring Str. 12, presently living at Dingolfing bei Regensburg, Rem Str. 160, employed as Bagger Fuhrer
5. Lieselotte DIEBRICH, nee DAUMANN born 10 February 1913 at Rehdorf bei Zipsendorf, DDR, married to Werner DIEBRICH on 27 December 1938, living at Volkach (near Weisburg), Ring Str. 12

Developments:

We have been pressing the investigation of this case, because the information by Otto, though up till now very reliable, still has not been verified in this instance, and we wish to avoid any unwarranted damage to anyone's reputation should the charges turn out to be unfounded.

According to Otto, HESCHMANN was directed by N'S Erfurt to develop contact with ZIEBNER and KIRLMANSEGG, all three of whom are said to be members of the Veterans Organization of the First Panzer Division. Otto does not know how successful HESCHMANN has been on this operation, and Otto believes that ZIEBNER and KIRLMANSEGG are unwitting of HESCHMANN's N'S ties.

To clear up this matter, we have been seeking contact with HESCHMANN. This we tried to achieve through DIEBRICH, whose wife is a half-sister of HESCHMANN. Otto reported that N'S Weimar had attempted to recruit DIEBRICH while he was visiting his wife in the DDR during the summer of 1950. DIEBRICH had been a member of the SS. After returning to West Germany, DIEBRICH reported his detention in the DDR and refused to continue contact with the N'S. HESCHMANN was sent to West Germany late in 1950 to investigate DIEBRICH's status.

We made contact with DIETRICH and Otto's information concerning DIETRICH was verified in every detail. However, DIETRICH claimed to have no contact with HECHMANN, and refused to seek any.

In the meantime, we have located ZIEGLER, and initial contact with him has verified the fact that he is a member of the Veterans of the First Panzer Division, and he acknowledges having heard of HECHMANN, whom he claims to know as FUCHSMANN or FUCHSMANN. ZIEGLER further admitted having once been approached by East Zone members of the Veterans group to work for the "BERG". This point was not pursued in the initial meeting with ZIEGLER, because it would have been incompatible with the cover used by the investigator. ZIEGLER agreed to inform the investigator if HECHMANN should visit West Germany. However, it should be noted that ZIEGLER appears to be aware of the investigator's true motives. It is hoped that this matter will be cleared up within the next few weeks.

Future Handling:

We indicated our desire to pursue this case, but we also expressed our willingness to withdraw, or to participate in a joint effort, should either of the latter approaches be deemed preferable. Traces were requested, particularly on ZIEGLER, but also with special attention to any unique capability perhaps available to achieve contact with HECHMANN.

1. Willi MOELLER, born c. 1922, living at Weimar, Schwabe Str. 15, formerly employed by NFS Weimar, and later NFS Berlin as a driver.
2. Frau MOELLER, Frau, wife of Willi MOELLER
3. Tilly MOELLER, daughter of Willi MOELLER
4. Frau IMU, born c. 1945, allegedly cousin of Willi MOELLER living in East Berlin
5. Otto, personal data known

Developments:

Contact with MOELLER was established via a letter written by Otto. However, instead of appearing at the meeting site in person, MOELLER sent his wife, who was accompanied by his daughter Tilly and an unidentified youth, allegedly a cousin living in East Berlin. MOELLER's wife claimed that Willi MOELLER had twisted his leg in an accident and was unable to travel. A succeeding meeting time and site was arranged, but MOELLER failed to appear. We have since learned that MOELLER is no longer employed by the NFS and have abandoned the case.

Future Handling:

We plan no further action in this case. However, should you desire to re-examine this lead, we are prepared to assist as possible.

10. Subject: Arthur Bruno TRUBNER, NIS Weimar secret informant

Persons Involved:

1. Arthur Bruno TRUBNER, born 15 November 1912, Tamaroda, living at Weimar, Bertuch Str. 40, employed as an independent taxi driver
2. Otto, personal data known
3. Lore, wife of Otto, personal data known
4. Ruth KUBERT, sister of Lore

Developments:

We made contact with TRUBNER when TRUBNER brought Otto's family to West Berlin. Upon his return to Weimar with Ruth KUBERT, it appears the latter was questioned by the NIS, who in turn probably implicated TRUBNER as having effected the escape of Otto's family to West Berlin. We have since learned from two different sources that he has been arrested. We do not intend to pursue this case.

Future Handling:

Should further action on this lead prove feasible, on either a unilateral basis by either party or on a joint effort, prior coordination will be effected.

Persons Involved:

1. Egon KLEINSTEUBER, born c. 1931, Gotha, living in Weimar, Ernst Thälmann Str. bei Fraulein Frau GRUND, employed as taxi driver with VEB Taxi, Weimar
2. Karin LORENZ, born c. 1931, living at [redacted], Platz der Deutschen Sowjetischen Freundschaft 1, bei GAES
3. Otto, personal data known

Developments:

Contact with KLEINSTEUBER via a letter written by Otto was achieved, and a meeting arranged. However, LORENZ appeared at the meeting site instead of KLEINSTEUBER, alleging that KLEINSTEUBER was in East Berlin but at the last moment had decided against entering the West sector for fear of being arrested by the West Berlin police. According to LORENZ, KLEINSTEUBER was anxious to see Otto and wanted Otto to come to him in East Berlin. Continued negotiations with KLEINSTEUBER through repeated trips by LORENZ from the West Sector to the East and return failed, and indications were strong that the operation was an NFS attempt to lure Otto into the East Sector. We do not plan to pursue this case.

Future Handling:

Should further action on this lead prove feasible, we are prepared to assist in any way possible.

12. Subject: ~~Ernid BIEBER~~, ex-NFS Weimar secret collaborator

Persons Involved:

1. Ernid BIEBER, born 22 February 1922, Karlsruhe/GSA, single, living at Neu-Isonburg bei Frankfurt/Main, Goethestr. 66, employed as a Ciemotechnikerin
2. Otto, personal data known
3. Heinz, personal data known

Developments:

According to statements of Otto and Heinz, BIEBER was recruited by NFS Weimar as a secret collaborator about 1953. Shortly thereafter she fled from the DRG, and it was not known whether she had departed on an NFS mission. At any rate, so much of Otto's and Heinz's allegations have been confirmed, in that BIEBER has admitted during her refugee processing that she had been approached by the NFS. We have located her at the above address, but have not yet approached her. Of particular significance in this case is the fact that she fled to West Berlin on 19 July 1955 and proceeded by commercial air to West Germany where she obtained employment and initiated refugee recognition proceedings on 1 September 1955. While this may be a completely explainable move on her part to avoid refugee processing in Berlin, and even though she admitted attempted recruitment by the NFS Erfurt as the reason for her flight in the course of her DRGV proceedings, it is noted that NFS Department XV habitually utilizes the technique of having agents they dispatch to the Federal Republic avoid refugee camps where the refugee is subject to interrogation by several security agencies; BIEBER appears to have utilized this technique to establish herself in the Federal Republic. It is also interesting to note that she is listed in the East German MVDVP Fahndungsbuch dated 1 January 1957 with correct last residence Berlin NO 55, Neugardstrasse 16.

Future Handling:

We do not plan to take any action on this case, unless future Joint discussions should indicate this more feasible. We feel this case should be investigated, and stand ready to provide tracing and research support.

Persons Involved:

1. Horst Heinrich HOELZ, born 5 March 1916, Ralinger, Kr. Trier, living at Weimar, Steinbeustr. 3, phone 35 16, lawyer
2. Otto, personal data known

Developments:

According to statements by Otto, HOELZ was recruited by the NFS about 1952. Otto learned this from HOELZ himself, who was Otto's personal lawyer, and Otto once saw the NFS file on HOELZ. It was known to Otto that HOELZ occasionally made trips to Western Europe. Though we have taken no action up till now, we are extremely interested in this case.

Future Handling:

Inasmuch as Otto will have legal matters to clear up concerning his wife's property in the DDR, Otto will have legitimate reason to invite HOELZ to confer with him in West Germany sometime in the near future. We have agreed to approach this target personality bilaterally, and we will recommend a date for further discussions on the matter. Traces would be of interest.
