MEMORANDUM FOR THE RECORD

SUBJECT: Operational Travel for GOMACE

1. In accordance with the operational objectives and tasks involving the establishment of front organizations and spotting of potential agents, specified under Project ZRNAUNTL, GOMACE was authorized to perform the following travel:

a. On 15 April 1957 GOMACE was authorized to travel from Toronto, Canada to Buffalo, N.Y. and return to Toronto. Purpose -- operational meeting with Case Officer. Travel performed on 15 April.

b. At April 15th meeting GOMACE was authorized to perform travel from Toronto, Canada to New York City and return. Purpose -- final briefing between GOMACE and Case Officer prior to overseas trip. Travel performed 27-30 April.

c. On 27 April 1957 GOMACE was authorized to travel from Toronto, Canada to Western Europe and return to Toronto. Travel in Europe was authorized to include travel in France, Germany, Austria, Italy and Spain. Purpose -- organization of emigre front organization and spotting of potential agents. Travel performed, 8 thru 25 May 1957.

d. After returning from overseas trip GOMACE was authorized to travel from Toronto, Canada to New York City and return. Purpose -- operational meeting with project Case Officer. Travel performed 5, 6 and 7 June 1957.

e. During meeting at New York City on 6-7 June, GOMACE was authorized to perform the following travel by private conveyance.

- (1) From Toronto, Canada to Montreal and Val David, Canada and return to Toronto. Travel performed 22 June thru 24 June 1957. Purpose -- organization of emigre front.

- (2) From Toronto, Canada to Detroit, Michigan to Chicago, Illinois to Toledo, Ohio to Buffalo, New York, to Toronto, Canada. Travel performed 5 July thru 10 July 1957.
- (3) From Toronto to Washington, D.C. and return to Toronto. Purpose -- meeting with Case Officer. Travel performed 16 July thru 19 July 1957.
- (4) On 17 July GOMACE was authorized to travel from Toronto, Canada to New York City on 12 August. Purpose -- final debriefing of trip.

2. Travel, per diem, operational expenses including inducement pay and entertainment were authorized for the above trips. Names of all persons indicated as receiving payment, operational gifts and entertainment are in the project files.
