SHAM ZERNAUNTSE BULGARIA

SUBJECT { GENERAL GOMACE
SPECIFIC

REFERENCE: BOFA 19847, 10 Jan 58 (KAPCK)

ACTION REQUIRED: None.

1. In regard to paragraph 3 of reference, GOMACE is utilized as a Bulgarian Principal Agent (PA) under Project ZERNAUNTSE. Although he made a three-week trip to Europe in the Spring of 1957 in order to spot potential ZERNAUNTSE assets among Bulgarian National Front (BNF) members, his activity is now limited to creating ZERNAUNTSE teams in the U.S. and Canada. We are in no way trying to promote or influence GOMACE's position within the BNF, the newly formed Bulgarian Representation Abroad (BRA), or his status with the King or any other prominent members of the Bulgarian emigre group.

2. Since most of our Bulgarian assets are members of the BNF, and still regard GOMACE as their leader, and since GOMACE is the only organizer and driving force within the BNF, he, GOMACE, is useful to us so long as he remains in his present position. However, we have heard that there may be an effort to oust GOMACE from his present position in the BNF during the coming BNF convention in New York on 1-3 March. We will not become involved in this squabble and will let nature take its course. Our future relations with GOMACE will depend upon the outcome of the BNF convention in March.

3. GOMACE has not been informed of our association with _____ or any other ZERNAUNTSE activity; however, GOMACE informed us at our last meeting on 13 February that in a letter he received from _____ that he, _____, believed _____ must be connected with the Americans, through whom _____ hoped would be a source of financial support for the BRA. We then informed GOMACE that we had no knowledge of any American support of the BRA, financial or otherwise, and that the success or failure of the BRA was of no concern of the Americans.
