((INTERVIEW GIVEN BY GUILLERMO MANUEL UNGO, FDR PRESIDENT, TO CORRESPONDENTS NELSON LOPEZ AND ROBERTO CASTAÑEDA; DATE AND PLACE NOT GIVEN -- LIVE OR RECORDED))

((TEXT)) ((LOPEZ)) DR UNGO, REGARDING THIS OCCURRENCE, THE FDR HAS INDICATED THAT THE ORGANIZATION HAS NO INFORMATION ON THE IDENTITY OF THE KIDNAPPERS OF INES GUADALUPE DUARTE DURAN. WHAT CAN YOU TELL US ABOUT THIS AND THE PEDRO PABLO CASTILLO ORGANIZATION THAT HAS BEEN MENTIONED?

((UNGO)) SO FAR, WE DO NOT KNOW THE IDENTITY OF THE KIDNAPPERS OF DUARTE'S DAUGHTER. WE OF THE FDR HAVE ANNOUNCED OUR STANCE, NAMELY, THAT WE DON'T KNOW WHO THE KIDNAPPERS ARE. IN ADDITION, IT IS OBVIOUS TO US THAT A POLITICAL FRONT COULD NOT HAVE CARRIED OUT THIS TYPE OF ACTION. ALSO, WE HOPE THE SITUATION CAN BE HANDLED PROPERLY SO THAT HER LIFE CAN BE SAVED.

THIS IS WHY WE ARE CONCERNED OVER SPECULATIONS AND PUBLIC STATEMENTS SUPPOSEDLY EXPRESSED BY THE GOVERNMENT. WE BELIEVE THE BEST COURSE OF ACTION AT THIS MOMENT WOULD BE TO WAIT AND NOT TO INTERFERE WITH ANY TYPE OF UNDERSTANDING NOW IN PROGRESS, OR THAT COULD BE ATTENDED IN THE NEAR FUTURE.

((LOPEZ)) DR UNGO, REGARDING THE KIDNAPPING, I WOULD LIKE YOU TO MAKE AN ANALYSIS AND ALSO TO TELL US YOUR OPINION ON THE REASONS FOR THE INCIDENT.

((UNGO)) AT THIS TIME WE ARE CONCERNED, AND WE ARE ALSO IGNORANT REGARDING WHO IS RESPONSIBLE FOR THIS ACTION AGAINST THE PRESIDENT'S DAUGHTER. I WORRIES US BECAUSE IT ACCENTUATES AND DEEPENS WHAT WE HAVE ALREADY SAID AT OTHER TIMES REGARDING THE VIOLENCE WHICH IS BECOMING INCREASINGLY WORSE. WE WOULD LIKE TO PLACE THIS WITHIN THE CONTEXT OF THOUSANDS OF MOTHERS AND FATHERS WHO SUFFER THE ANGUISH AND PAIN OF THE DISAPPEARANCE OF RELATIVES, OF CHILDREN WHO HAVE BEEN KIDNAPPED OR MURDERED. THIS IS NOT AN ISOLATED CASE; IT IS THE PRODUCT OF A WAR SITUATION. WE HAVE ALWAYS INSISTED, AND NOW MORE THAN BEFORE, THAT IT IS EVIDENTLY ESSENTIAL THAT WE SEEK A POLITICAL SOLUTION THROUGH DIALOGUE, A DIALOGUE THAT UNFORTUNATELY WAS INTERRUPTED BY THE GOVERNMENT, BY ENGINEER DUARTE HIMSELF. WE REGRET THIS SITUATION, HOPE THAT A SATISFACTORY RESULT IS ACHIEVED, AND IN ANY CASE ARE MAINTAINING AN ATTITUDE OF HESITATION, CAUTION, AND HOPE.

AS I RECENTLY SAID DURING PUBLIC STATEMENTS BY THE FDR, WE ARE AND CONTINUE TO BE IGNORANT, AND THAT IN THIS SITUATION WE CANNOT HINDER ANY POSSIBLE ATTEMPT OF UNDERSTANDING TO ACHIEVE A SATISFACTORY SOLUTION FOR ENGINEER DUARTE'S DAUGHTER. WE ARE CONCERNED OVER CERTAIN IRRESPONSIBLE ACTIONS BY THE SALVADORAN GOVERNMENT IN THIS REGARD, BECAUSE EVERYTHING WE KNOW IS THROUGH THE MEDIA AND NOT THROUGH STATEMENTS FROM THOSE DIRECTLY INVOLVED, REGARDING WHETHER IT IS THE PEDRO PABLO CASTILLO FRONT, OR THE FMLN, OR ANY OTHER ORGANIZATION THAT DOES NOT BELONG TO THE FMLN, OR IF IT IS THE SALVADORAN RIGHTWING.

WE BELIEVE THAT THIS IS NOT THE TIME TO PUBLICLY SPECULATE. IT IS THE TIME TO WAIT, TO ACT RESPONSIBLY, SEEKING A SATISFACTORY RESULT. THE GOVERNMENT PROBABLY HAS INFORMATION; WE DO NOT KNOW HOW MUCH, WE DO NOT KNOW IF THE GOVERNMENT IS SAYING THE TRUTH OR ALL THE TRUTH, AND IN THIS REGARD I BELIEVE THAT AS LONG AS WE DO NOT KNOW WHO IS DIRECTLY RESPONSIBLE FOR THIS ACTION WE CANNOT SPECULATE OR EXPRESS OPINIONS. WE MUST TRY NOT TO HINDER THE EFFORTS, AND, I REPEAT, HOPE FOR A SATISFACTORY RESULT.

((LOPEZ)) DOCTOR, IT HAS BEEN REPORTED BY THE DIFFERENT MEDIA THAT THE GROUP THAT HAS CLAIMED RESPONSIBILITY IS CALLED THE PEDRO PABLO CASTILLO GROUP. TAKING INTO ACCOUNT THAT THIS IS A NEW TURN OF EVENTS, WE WOULD LIKE TO KNOW IF YOU HAVE ANY INFORMATION ON THIS NEW MILITARY FRONT, WHICH -- AS IT HAS STATED -- BELONGS TO THE FMLN, AND IF YOU HAVE ANY KNOWLEDGE OF THE PETITIONS OF THE FRONT REGARDING COMMANDERS WHO HAVE BEEN CAPTURED.

((UNGO)) NO. ALL I KNOW IS WHAT IS IN THE INTERNATIONAL PRESS, WHERE THERE ARE CONTRADICTORY STATEMENTS. THEY SAY THAT THIS FRONT IS A POLITICAL FRONT OF POLITICAL PRISONERS AND IT THEREFORE COULD NOT HAVE AN ACTIVE MILITARY FORCE BECAUSE THE MEMBERS ARE PRISONERS. THERE ARE SPECULATIONS THAT IT COULD BE AN AUTONOMOUS COMMAND, OR THAT IT BELONGS TO ONE OF THE FMLN ORGANIZATIONS. THEREFORE, ALL OF THIS IS SPECULATION, AND I AM CONCERNED OVER HOW THIS INFORMATION WAS OBTAINED, BECAUSE AT THIS TIME WE HAVE NO INFORMATION THAT ANY ORGANIZATION OF FRONT, OR WHATEVER YOU WANT TO CALL IT, HAS DIRECTLY ASSUMED RESPONSIBILITY FOR THIS. I AM ALSO UNAWARE OF THE STATEMENTS THAT HAVE BEEN MADE IF INDEED STATEMENTS HAVE BEEN MADE. I BELIEVE THAT THE GOVERNMENT IS AWARE OF THEM, BUT WANTS TO HANDLE THE SITUATION IN A DISCREET WAY. I BELIEVE THAT WE MUST NOT ACCEPT THE TERMS THAT COULD BE UNDER NEGOTIATION NOW OR IN THE FUTURE. ALL IN ALL WE ARE REALLY IN THE DARK, AND WE DO NOT WANT TO PLAY THE BLIND CHICKEN (LA GALLINA CIEGA; THIS IS THE SPANISH NAME FOR A GAME SIMILAR TO BLIND MAN'S BLUFF -- FBIS)). THIS IS THE POSITION OF THE FDR, AND IN THIS REGARD, WE ARE AWAITING FURTHER INFORMATION IN ORDER TO HAVE A CLEAR PICTURE AND ADOPT A POSITION, AS WELL AS AN OPINION.

TAKE 2 OF 3 -- EL SALVADOR: FDR'S UNGO ON KIDNAPPING

((TEXT)) ((UNGO CONTINUES)) IT IS IMPORTANT TO TAKE INTO CONSIDERATION THE FACT THAT THIS HAPPENED SEVERAL DAYS AGO; EVERYTHING LEADS US TO THINK -- ALTHOUGH WE CANNOT BE CERTAIN -- THAT THE DAUGHTER OF ENGINEER DUARTE IS ALIVE. WE ALSO LEARNED -- BUT DO NOT KNOW WHETHER IT IS TRUE -- THAT THERE WAS A CONTACT BETWEEN THE ENGINEER AND HIS DAUGHTER. THAT IS WHAT SOME NEWSPAPERS CLAIMED, BUT WE DO NOT KNOW THAT FOR CERTAIN. SHOULD THIS BE TRUE, THIS WOULD KEEP OUR HOPES ALIVE THAT THE SITUATION WILL HAVE A SATISFACTORY CONCLUSION.

((LOPEZ)) YES, DOCTOR, REGARDING THE MEETING THAT WAS SCHEDULED BETWEEN THE FDR WITH MR HECTOR OQUELI COLINDRES AND JULIO ADOLFO REY PRENDES, THE MINISTER OF CULTURE AND COMMUNICATIONS, WE WOULD LIKE TO KNOW WHETHER YOU HAD ANY ADVANCE KNOWLEDGE ABOUT THAT AND WHAT TOPICS WOULD HAVE BEEN DISCUSSED SHOULD THE MEETING HAVE MATERIALIZED?

((UNGO)) I DON'T REALLY KNOW WHAT IS IN THE MIND OF THE GOVERNMENT AND THE CULTURE AND COMMUNICATIONS MINISTER. I DON'T WANT TO SPECULATE ON THAT. HOWEVER, WE SEE THIS AS A DANGEROUS POLITICAL, PROPAGANDA GAME WHICH WE ARE DENOUNCING. THIS, AT A TIME WHEN A PERSON'S LIFE IS AT RISK. THERE WERE LEAKS -- NOT BY US -- THAT THERE WAS AN ATTEMPT TO SEEK CONTACT WITH THE REBELS, AND THUS IT WAS ALMOST SUGGESTED THAT WE ARE TO BLAME FOR THE ACTION.

REGARDING THIS, THE FDR REJECTS THIS KIND OF MANEUVER BECAUSE WE HAVE NOT AND COULD NOT HAVE PARTICIPATED IN IT. THE FDR DOES NOT WANT TO GIVE ANY ROOM TO POLITICAL SECTORS THAT SOMETIMES APPARENTLY FORGET THE MAIN OBJECTIVE AT THIS MOMENT, AND INSTEAD ARE SEARCHING FOR POLITICAL GAIN AND POSITIONS THAT ARE NOT IN LINE WITH THE TRUE SITUATION.

IT IS EVIDENT THAT THAT NEWS DID NOT COME FROM US. THAT NEWS TEAKED OUT FROM SOMEWHERE ELSE AND WAS RAPIDLY MADE PUBLIC EVEN BY THE U.S. PRESS AND THE OFFICIAL U.S. RADIO STATION, THE VOICE OF AMERICA.

AS I SAID, THEY WERE KNOCKING ON THE WRONG DOOR. OUR DOOR IS NOT THE ONE LEADING TO THE CLARIFICATION OF A SITUATION THAT WE DO NOT KNOW ABOUT, AND IN WHICH WE ARE NOT INVOLVED. THEREFORE, AT THIS TIME, WE CANNOT HELP IN REACHING AN AGREEMENT, BECAUSE WE DO NOT REALLY KNOW WHAT THE GOVERNMENT KNOWS, WHO IT IS NEGOTIATING WITH, OR WHETHER IT IS NEGOTIATING AT ALL. THEY ARE SIMPLY USING US TO CARRY OUT A POLITICAL, PROPAGANDISTIC GAME THAT IS VERY CHARACTERISTIC OF OBJECTIVES THAT LEAD TO THE

CREATION THAT ((WORD INDISTINCT)) MINISTRY.

THEREFORE, THERE IS NOTHING SPECIFIC ON THIS. WE HEARD STATEMENTS BY REY PRENDES HIMSELF THAT HE WAS UNABLE TO MAKE ANY CONTACT AND COULD NOT LEARN ABOUT THE SITUATION WHEN THEY SUPPOSEDLY KNOW ABOUT IT, AND ARE USING IT FOR SEVERAL PURPOSES IN DIFFERENT WAYS.

THEREFORE, I BELIEVE THAT REY PRENDES' TRIP IS A FALSE TRIP. HE KNOCKED ON A WRONG DOOR. HE WAS SIMPLY LOOKING FOR POLITICAL OBJECTIVES TO TRY TO POINT THE RESPONSIBILITY OR SOME KIND OF INVOLVEMENT AT A TARGET THAT IS POSSIBLY RESPONSIBLE. IT IS INTERESTING THAT THEY TRIED TO BLAME US AND INVOLVE US IN SOMETHING THAT WE ARE NOT INVOLVED IN.

IN ADDITION, WE ARE DESPISED AND BELITTLED BECAUSE THEY CLAIM THAT WE DO NOT HAVE MUCH INFLUENCE.

THIS IS A DIRTY AND CUNNING GAME THAT WE REJECT. WE BELIEVE THAT WE ARE HELPING IN THIS WAY TO SOLVE THIS REGRETTABLE SITUATION IN A POSITIVE WAY, AND ARE OPPOSING THAT THE LIFE OF A PERSON BE USED TO MAKE POLITICAL GAINS.

((LOPEZ)) REPORTS COMING FROM ABROAD, SPECIFICALLY IN THE NEW YORK TIMES, INDICATED THAT EFFORTS WERE ALREADY BEING MADE -- VIA AN INTERMEDIARY -- TO REACH AN AGREEMENT, A MEETING IN AN AREA CONTROLLED BY THE GUERRILLA. ((AS HEARD)) THE NEW YORK TIMES QUOTES SALVADORAN SOURCES ON THIS.

IN ADDITION, IT IS SAID THAT THIS GROUP, WHICH IS SUPPOSEDLY HOLDING THE DAUGHTER OF THE PRESIDENT OF THE REPUBLIC, ASKED A SUSPENSION OF ALL GOVERNMENT MILITARY OPERATIONS TO FACILITATE NEGOTIATIONS ON THE KIDNAPPING AND AT THE SAME TIME THE RELEASE OF 12 GUERRILLAS BEING HELD IN JAILS. DR. GUILLERMO MANUEL UNGO, DO YOU KNOW ANYTHING ABOUT THIS?

((UNGO)) I KNOW NOTHING ABOUT THIS. REGARDING THIS, I INSIST THAT WE DO NOT WISH TO TAKE ACTIONS, MAKE DECISIONS, AND GIVE OPINIONS OR CREATE SPECULATIONS THAT WILL NOT CONTRIBUTE TO SOLVING THE PROBLEM, THIS DIFFICULT AND REGRETTABLE SITUATION.

THEREFORE, IN THIS REGARD, WE HAVE HEARD MANY VERSIONS AND WE HAVE TO IMPOSE OURSELVES ((WORDS INDISTINCT)) RESPONSIBILITY TO NOT CONTRIBUTE TO CREATING REPORTS WHICH WE DO NOT KNOW WHETHER THEY WILL TURN OUT TO BE TRUE OR NOT.

ALL WE KNOW IS THE RESULT OF OUR INVESTIGATIONS. THIS IS VERY LIMITED, THERE IS LITTLE INFORMATION, AND MUCH SPECULATION. IT IS ((LIKE HITTING A GOAL BLINDFOLDED)).

((TEXT)) ((LOPEZ)) TO CONCLUDE, DR GUILLERMO MANUEL UNGO,
WE WOULD LIKE YOU TO ANSWER THIS QUESTION VERY SINCERELY. IT HAS
BEEN SAID ON MANY OCCASIONS THAT YOU AND JOSE NAPOLEON DUARTE
WERE GOOD FRIENDS FOR MANY YEARS, AND THAT YOU HAD A CLOSE
RELATIONSHIP. NOW, THAT YOU ARE ON OPPOSITE SIDES, WHAT HAS BEEN
JOSE NAPOLEON DUARTE'S REACTION CONCERNING THE KIDNAPPING OF
HIS DAUGHTER? -HAS HE TRIED TO CONTACT YOU DIRECTLY TO TALK
ABOUT THE ISSUE?

((UNGO)) NO, NOT DIRECTLY, BUT HE HAS TRIED THROUGH OTHER
CHANNELS. I THINK IT IS NORMAL FOR HIM TO TRY TO SEEK SOME SORT
OF SUPPORT OR COOPERATION TO SAVE HIS DAUGHTER'S LIFE. I HAVE
GIVEN HIM A POSITIVE ANSWER IN THE SENSE THAT WE HOPE EVERYTHING
WILL BE SOLVED SATISFACTORILY. IF WE COULD HELP IN ANY WAY, WE
WOULD FIND A WAY OF DOING THIS. THERE IS NOTHING WE CAN DO AT THE
MOMENT, WE HAVE NO INFORMATION ON THIS SITUATION, BECAUSE IT IS NOT
IN OUR HANDS TO BE HANDLED, WE DO NOT KNOW HOW THIS IS BEING
HANDLED, OR WHO IS HANDLING THE ISSUE. THUS, WE ARE CONCERNED
ABOUT THE MATTER, AND HOPE EVERYTHING WILL BE SOLVED FAVORABLY,
AND WE MUST WAIT. I HAVE HAD A PERSONAL RELATIONSHIP WITH DUARTE,
BUT NOT A POLITICAL RELATIONSHIP IN THE PAST, AND THE RIGHTISTS
HAVE MALICIOUSLY MANIPULATED THIS, TRYING TO POINT OUT THAT WE
CONTINUE ON THE SAME TERMS. I THINK WE SHOULD NOT MIX PERSONAL
RELATIONSHIPS WITH POLITICS. I DO NOT THINK WE SHOULD MIX HUMAN
CONSIDERATIONS WITH POLITICAL CONSIDERATIONS.

((LOPEZ)) THANK YOU FOR YOUR ANSWER. ROBERTO CASTANEDA ALSO
HAS A QUESTION HE WOULD LIKE TO ASK YOU ON BEHALF OF RADIO CADENA
SONORA AND ITS LISTENERS.

((CASTANEDA)) GOOD MORNING, DOCTOR. I WOULD LIKE TO ASK
YOU JUST ONE QUESTION, I REALIZE YOU ARE A VERY BUSY MAN. THERE
IS GREAT CONCERN HERE. WE WOULD LIKE TO KNOW IF YOU ARE IN
CONTACT WITH MR DUARTE AS HIS FRIEND, THAT IS, ON AN UNOFFICIAL
BASIS, OR A PERSONAL BASIS.

((UNGO)) NO, WE HAVE NOT HAD ANY PERSONAL DIRECT CONTACT WITH
MR DUARTE. THE LAST TIME WE SAW EACH OTHER WAS NEARLY 1 YEAR
AGO AT LA PALMA. WE HAVE NOT HAD ANY PERSONAL CONTACT, WHICH
MEANS I HAVE NOT AVOIDED HIM. THERE HAVE BEEN SOME OPPORTUNITIES
WHEN THIS COULD HAVE OCCURRED, DURING ANY OF HIS TRIPS OR MY TRIPS,
HOWEVER, HE HAS AVOIDED ME.

((CASTANEDA)) ((QUESTION INDISTINCT))

((UNGO)) I HAVE ALWAYS SAID THAT I NEVER MIX POLITICS WITH
PERSONAL AFFAIRS.
