

LEAVE THE ARMED FORCES ONLY IF LIEUTENANT COLONEL RENE EMILIO ((PONCE)), THEN CHIEF OF THE MOTOR VEHICLE DEPARTMENT OF THE NATIONAL POLICE, WAS NAMED AS HIS SUCCESSOR. PONCE, WHO HAD SERVED AS MORAN'S SECOND IN COMMAND IN THE TREASURY POLICE, WAS A CLOSE FRIEND. ACCORDING TO MORAN, PONCE SHARED HIS VIEWS ON HOW THE TREASURY POLICE SHOULD BE RUN AND WOULD MAINTAIN THE TREASURY POLICE AS A NEARLY AUTONOMOUS ORGANIZATION WITHOUT PARTISAN POLITICAL CONNECTIONS. MORAN STATED THAT ARENA HOPED TO GAIN CONTROL OF THE TREASURY POLICE BY NAMING A SYMPATHIZER TO THE DIRECTOR'S POSITION.

REPORTED THAT MORAN, PRESIDENT OF THE RIO LEMPA HYDROELECTRIC COMPANY (CEL), WAS PLOTTING AGAINST THE LIVES OF COLONEL ADOLFO ((BLANDON)) MEJIA, THEN COMMANDER OF FIRST INFANTRY BRIGADE, AND COL. JUAN RAFAEL ((BUSTILLO)), AIR FORCE COMMANDER. IT WAS [REDACTED] BELIEF THAT MORAN WAS A CLOSE FRIEND OF FORMER DEFENSE MINISTER, GENERAL JOSE GUILLERMO ((GARCIA)). [REDACTED]

7. ON 23 APRIL 1985, [REDACTED] RECEIVED INFORMATION [REDACTED] THAT COL MORAN, FORMER CHIEF OF THE TREASURY POLICE AND THEN HEAD OF CEL, WAS VERY ACTIVE IN DEATH SQUAD ACTIVITIES. MORAN WAS SUPPOSED TO BE DIRECTING THE ACTIVITIES OF TWO LEFTIST GUERRILLAS RECRUITED BY THE RIGHT TO EOMMIT ASSASSINATIONS, BOMBINGS, AND OTHER TERRORIST ACTIVITIES. THE GUERRILLAS WERE CALLED "LOS ANGELITOS" AND HAD A NATURAL COVER AS LEFTIST GUERRILLAS. ACCORDING TO THE LIAISON SERVICE SOURCE, MORAN DID NOT MEET THEM DIRECTLY BUT USED RICARDO ANTONIO ((ROGEL)) AS HIS INTERMEDIARY.
