STATED

[REDACTED] THAT THE FOREIGN POWERS WERE AWARE NOW THAT THE LIFETIME PRESIDENCY WAS A SERIOUS MATTER, BECAUSE NOT ONLY THE ARMY, THE MILITIA, AND ALL THE HAITIAN PEOPLE SUPPORTED HIM BUT ALSO THE JUDICIARY WHICH RECENTLY CAME TO HIM TO PAY HOMAGE . DUVALIER POINTED OUT [REDACTED] THAT FORMER

AMERICAN AMBASSADOR RAYMOND THURSTON USED TO CONDUCT HIMSELF IN AN ARROGANT FASHION AND TALK LIKE A "BIG-SHOT WHITE MAN" AS WAS DONE DURING THE ERA OF THE CHARTER OF CHAPULTEPEC AND THE MONROE DOCTRINE WHEN "THE BIG ONES USED TO EAT THE LITTLE ONES." BUT NOW, ACCORDING TO DUVALIER, THINGS ARE DIFFERENT, AND THESE TACTICS CAN NO LONGER SUCCEED. REFERENCE TO "\$300,000" CLEARLY REFERS TO INTER-AMERICAN DEVELOPMENT BANK LOAN, WHICH WAS AMONG SUBJECTS DISCUSSED AT VARIOUS TIMES BETWEEN FOREIGN MINISTER CHALMERS AND AMBASSADOR ALTHOUGH SUCH LOAN NOT "PROMISED" BY US GOVERNMENT SINCE IT MADE BY INTERNATIONAL LENDING ORGANIZATION. RESUMPTION OF TOURISM ALSO DISCUSSED BETWEEN CHALMERS AND AMBASSADOR, BUT REOPENING OF AID MISSION HAS NEVER

IF THIS HAPPENED, DUVALIER STATED, HE WOULD BE OVERTHROWN IN A DAY, AND PEOPLE WOULD SAY AS THEY DID DURING THE TIME OF FORMER PRESIDENT DUMARSAIS ESTIME THAT HE HAD LOST CONTROL OF THE SITUATION. DUVALIER TOLD THE GROUP THAT WHEN THE AMERICANS PROMISED SOMETHING, IT WAS A JOKE, AND ASKED WHERE WERE THE \$300,000, THE TOURIST BOATS THAT WERE SUPPOSED TO COME TWO OR THREE TIMES A WEEK, AND THE NAVAL SHIPS THAT WERE SUPPOSED TO COME EVERY SATURDAY AND GIVE 21-GUN SALUTES. ( COMMENT: IN DISCUSSIONS BETWEEN CHALMERS AND AMBASSADOR, IT/NEVER INDICATED GRACE LINE CRUISE SHIPS WOULD COME "TWO OR THREE TIMES A WEEK". US NAVAL VISITS HAVE ALSO BEEN DISCUSSED, BUT AMBASSADOR HAS MADE CLEAR THAT NO REGULAR SCHEDULE WAS INVOLVED. QUESTION OF FIRING SALUTES HAS NEVER ARISEN, AND AMBASSADOR HAS MADE CLEAR VISITS WERE ONLY FOR LIBERTY PURPOSES.)
