BEEN SENT BY ANTONIO IMBERT BARRERA AND IT

MEANT THAT THE PORTION OF THE MASFERRER INVASION FORCE WHICH WAS IN THE DOMINICAN REPUBLIC HAD REACHED A PREVIOUSLY AGREED POSITION IN THE DOMINICAN REPUBLIC.

3. MASFERRER PLANS TO INSTRUCT HIS FOLLOWERS TO ASSEMBLE IN SMALL GROUPS AT DESIGNATED PLACES IN MIAMI MASFERRER PLANS FOR THE MEN TO BE PICKED UP AND TAKEN TO AN INVASION SHIP WHICH IS NOW OUTSIDE THE TERRITORIAL LIMITS OF THE UNITED STATES.

4. THE SEABORNE INVASION FORCE HAS ABANDONED PLANS TO LAND IN HAITI IN RUBBER BOATS WITH SILENT MOTORS BECAUSE OF THE POOR CONDITION OF THE BOATS AND MOTORS. INSTEAD THEY WILL USE MOTOR BOATS.
