1. Developments in Korea have caused considerable anxiety in Salvadoran Communist circles, since Communist leaders have anticipated that stringent anti-Communist measures would probably be taken by Salvadoran authorities should the world situation grow worse. Accordingly, the expansive plans of the Comité Revolucionario Estudiantil (CRE) are being modified, and tentative plans for the immediate future have been outlined by CRE leaders.
2. The immediate plans of CRE leaders include a strengthening of the Accion Revolucionaria Salvadoreña (ARS), stressing its nationalistic objectives in order to camouflage the Communist line; the formation of a study group to advance the committee's knowledge of clandestine operations; and the infiltration of all groups supporting the United States and the western democracies. However, for a concrete policy on their activities in the future, CRE leaders are awaiting detailed instructions from Guatemala.
