1. DURING THE WEEK OF [REDACTED] SEPTEMBER, [REDACTED] MET [REDACTED] TO EXPRESS HIS VIEWS ON THE CURRENT SITUATION IN CHILE. [REDACTED] SAID HE BELIEVED THE GOVERNMENT WAS MAKING PROGRESS IN EASING THE CIVIL RIGHTS PROBLEM. HE EXPRESSED CONCERN, HOWEVER, OVER THE CONTINUING REPORTS OF DETAINEES WHOSE RELATIVES ARE NEITHER NOTIFIED OF THEIR WHEREABOUTS NOR OF THE CHARGES AGAINST THEM.

2. [REDACTED] SAID HE SUPPORTED THE GOVERNMENT'S ANNOUNCED INTENT TO RELEASE POLITICAL PRISONERS. HE AGREED TO MEET WITH THE MEMBERS

OF THE JUNTA TO FORMULATE AND CO-SIGN A DOCUMENT WHICH WOULD SET FORTH THE DETAILS GOVERNING THE RELEASE OF PRISONERS. THE DOCUMENT WOULD ALSO CALL ON THE SOVIET UNION AND CUBA TO TAKE SIMILAR ACTION. [REDACTED] WARNED, HOWEVER, THAT IF HE SIGNED SUCH A DOCUMENT, HE EXPECTED THE JUNTA TO FULFILL ITS END OF THE BARGAIN. ([REDACTED] COMMENT: IT IS NOT CLEAR IF THE GOVERNMENT OFFICIAL HAD PRIOR AUTHORITY OF THE JUNTA TO MAKE THE PROPOSAL FOR A JOINT DOCUMENT, OR IF IT WAS A SUGGESTION THAT WILL BE PASSED TO THE JUNTA FOR CONSIDERATION.)
