1. [REDACTED] COMMENT: [REDACTED] IR 0184 OF 7 NOVEMBER 1973 REPORTED ON THE INVESTIGATION OF PERSONS IN THE ARMED FORCES AND UNIFORMED NATIONAL POLICE (CARABINEROS) SUSPECTED OF HAVING CONNECTIONS WITH THE FORMER POPULAR UNITY (UP) GOVERNMENT.)

[REDACTED] TO DATE, THE INVESTIGATIONS HAVE SHOWN THAT BOTH THE MOVEMENT OF THE REVOLUTIONARY LEFT (MIR) AND THE SOCIALIST PARTY (PS) WERE SUCCESSFUL IN EFFORTS TO INFILTRATE MILITARY UNITS AT THEIR LOWER LEVELS IN ORDER TO ATTEMPT SUBORNATION, [REDACTED]

[REDACTED] EVIDENCE UNCOVERED HAS SHOWN THAT THE INFILTRATION EFFORTS OF THE COMMUNIST PARTY OF CHILE (PCCH) WERE LARGELY UNSUCCESSFUL. MOST INDICATIONS ARE THAT WHILE THE PCCH DID HAVE MILITARY CONTACTS, THEY WERE SUPERFICIAL AND DID NOT REPRESENT ORGANIZED INFILTRATION AND THE CREATION OF CELL TYPE STRUCTURES.

3. THE ARMY TEAM HAS WORKED IN CLOSE COOPERATION WITH THE AIR FORCE TEAM, HEADED BY GENERAL ORLANDO GUTIERREZ. FOR SECURITY REASONS, ARMY PERSONNEL HAVE CONDUCTED RAIDS AND INTERROGATIONS AS FOLLOW-UP TO INFORMATION DEVELOPED FROM AIR FORCE INVESTIGATIONS, AND AIR FORCE PERSONNEL HAVE BEEN USED FOR FOLLOW-UP ON INVESTIGATIONS OF ARMY PERSONNEL, BOTH THE

ARMY AND AIR FORCE HAVE USED PHYSICAL FORCE IN SOME INTERROGATIONS; MANY PERSONNEL WHO HAVE TO PARTICIPATE IN SUCH INTERROGATIONS ARE NOT HAPPY ABOUT THEIR TASK EVEN THOUGH THEY HAVE BEEN TOLD THAT THE JOB IS NECESSARY TO CLEAN OUT RESIDUAL POCKETS OF INFILTRATION WITHIN THE ARMED FORCES. THE OFFICERS HAVE ALSO BEEN TOLD THAT THEY HAVE BEEN SELECTED BECAUSE OF THEIR KNOWN HONESTY AND LOYALTY.

4. IN CONTRAST WITH THE COOPERATION BETWEEN THE ARMY AND AIR FORCE, THE NAVY HAS OPPOSED ANY FORM OF COOPERATION IN ITS INVESTIGATIVE EFFORTS. IN A SIMILAR MANNER, THE CARABINEROS HAVE CONDUCTED THEIR OWN INVESTIGATIONS WHICH RESULTED IN PUNITIVE ACTIONS TO SEVERAL OFFICERS SHORTLY AFTER 11 SEPTEMBER. HOWEVER, THE ARMY AND THE OTHER SERVICES BELIEVE THE CARABINEROS HAVE NOT MADE THE FOLLOW-UP INVESTIGATIONS NECESSARY FOR A THOROUGH JOB,
