COMMENT: HARBURY SAYS SHE IS THE WIFE OF BAMACA, WHO WAS EITHER CAPTURED OR KILLED BY THE GUATEMALAN ARMY ON 12 MARCH 1992. HARBURY CONDUCTED A HUNGER STRIKE IN GUATEMALA CITY FROM 11 OCTOBER TO 11 NOVEMBER TO DEMAND THE RELEASE OF BAMACA, WHO SHE BELIEVES IS ALIVE AND BEING HELD IN AN ARMY "CLANDESTINE PRISON.")

[REDACTED] THE FATHER OF EFRAIN BAMACA, JOSE ((BAMACA)), TO [REDACTED] TESTIFY IN THE CASE.

JOSE BAMACA ORIGINALLY TOLD OFFICIALS [REDACTED] THAT HE SAW HIS SON SHORTLY BEFORE HE DIED OR WAS CAPTURED, AND THAT HE MADE NO MENTION OF BEING MARRIED TO A U.S. CITIZEN OR HAVING SPENT TIME IN THE U.S. [REDACTED] COMMENT: IN PUBLIC DECLARATIONS, THE SENIOR BAMACA SAID HE HAD NOT SEEN HIS SON SINCE HE WAS ABOUT 18 YEARS OF AGE. THE VERY SIMPLE AND OBVIOUSLY OVERWHELMED BAMACA ALSO TOLD REPORTERS THAT HE HAD NEVER SEEN AN AMERICAN WOMAN BEFORE, AND DOUBTED THAT HIS SON WOULD HAVE MARRIED ONE. JOSE BAMACA ALSO MADE IT CLEAR THAT HE DID NOT WANT TO BE INVOLVED IN HARBURY'S EFFORTS TO GAIN THE RELEASE OF EFRAIN BAMACA. ACCORDING TO THE 13 NOVEMBER EDITION OF GUATEMALA CITY DAILY "SIGLO VEINTIUNO," THE ATTORNEY GENERAL'S OFFICE IS NOW INVESTIGATING THE VALIDITY OF A BAMACA/HARBURY MARRIAGE CERTIFICATE WHICH DOES NOT BEAR THE SIGNATURES OF EITHER PARTY BUT WAS ISSUED IN TEXAS ON 22 JUNE 1993 (SIC.)
