1. [REDACTED] has reported that a lecture entitled "The Soledad Brothers Trial" was held at the American Center for Students and Artists in Paris, France, on 12 October 1970. Among the individuals present at the lecture were: Jean GENET; John THORNE, defense lawyer for the Soledad Brothers; Susan GEORGE; Victor HERBERT, American millionaire living in Paris and possibly connected with the Investors Overseas Service; James BALDWIN; and Ellen WRIGHT.

2. The lecture was given by John THORNE in English to a predominantly American audience, estimated at around 600. In his presentation, THORNE made the following points:

A. The Soledad Brothers are victims of the institution.

B. The killing of the guard was staged (THORNE explained that at the Soledad Prison, blacks and whites are kept segregated and are never allowed to mix. The guard was killed during an exercise break in which both blacks and whites were unexplainably allowed to exercise together).

C. Racial tensions were immensely high in the Soledad prison which set the stage for an incident.

D. THORNE contended that the jury should consist of some prisoners who could shed some insight on the actual conditions of prison life and interpret the actions in their true perspective.

E. The only proof that the State has against Angela DAVIS is based on the fact that she signed her autograph at the request of the gun dealer who sold her the pistol. The other guns which she had bought some two or three years ago had been stolen and reported by DAVIS to the authorities.

F. The alacrity with which she was placed on the 10 most wanted list prejudices her chances for a fair trial since individuals on the list are usually considered armed and dangerous and by inference are guilty.
