2. YOU ARE OPERATING ON TWO SETS OF INSTRUCTIONS:
  - A. [REDACTED] (TRACK ONE) - AS OUTLINED IN JOHNSON MESSAGE TO KORRY (DIRECTOR [REDACTED]) WHICH IS BASED ON PARLIAMENTARY SOLUTION TO DEPRIVE ALLENDE OF PRESIDENCY. JOHNSON MESSAGE PROVIDES STRICT OUTLINE OF LIMITS OF ACTION UNDER THIS COORDINATED AUTHORITY.
  - B. [REDACTED] (TRACK TWO) - THIS IS AUTHORITY GRANTED [REDACTED] TO [REDACTED] ONLY, TO WORK TOWARD A MILITARY SOLUTION

TO PROBLEM. AS PART OF AUTHORITY WE WERE EXPLICITLY TOLD THAT [REDACTED] STATE, AMBASSADOR AND EMBASSY WERE NOT TO BE TOLD OF THIS TRACK TWO NOR INVOLVED IN IT IN ANY MANNER.

3. YOUR SUGGESTION OF HAVING STATION URGE (REPEAT HAVING STATION URGE) KORRY TO VISIT FREI AND SUGGEST MILITARY SOLUTION IS EXCELLENT AND WOULD BE WORKABLE IF WE WERE WORKING IN TANDEM. WE ARE NOT. THIS WOULD BE TANTAMOUNT TO HAVING KORRY ACT AS UNWITTING AGENT IN IMPLEMENTING TRACK TWO OF WHICH HE IS NOT AWARE AND IS NOT TO BE MADE AWARE. IF HE DECIDES TO DEFY DEPARTMENT INSTRUCTIONS AND ACT ON HIS OWN THAT IS HIS AFFAIR BUT STATION CANNOT BE PARTLY TO PUSHING HIM IN THAT DIRECTION SINCE WOULD BE VIOLATION OF OUR [REDACTED]
