1. [REDACTED] OCTOBER 1964, LOUIS DEJOIE [REDACTED] OFFERED THE SERVICES OF 100 MEN TO ASSIST ELIE IN HIS PLANS TO LIBERATE HAITI. DEJOIE SAID THE MEN WERE IN THE DOMINICAN REPUBLIC. ELIE [REDACTED] WOULD CONSIDER THE OFFER BUT [REDACTED] NONE OF THE NEW YORK EXILE GROUPS SHOULD BE INFORMED OF THE OFFER. ELIE [REDACTED] HAD NO WEAPONS AND [REDACTED] DEJOIE WOULD HAVE TO SUPPLY WEAPONS FOR HIS MEN. DEJOIE SAID HE WAS LEAVING FOR THE DOMINICAN REPUBLIC TEMPORARILY AND WAS GOING TO SAN JUAN, PUERTO RICO, WHERE HE WOULD RESIDE AT AVENIDA MUNOZ RIVERA, NO. 922, RIO PIEDRAS, AND HIS TELEPHONE NUMBER WOULD BE 765-2650 OR 765-3915. DEJOIE ALSO
