1. ON NOVEMBER 1964

SAID THAT THE HAITIAN EXILES HAVE ONE BOAT IN THE MIAMI AREA WHICH IS TO BE USED AS A PERSONNEL CARRIER. HOWEVER SINCE THAT BOAT IS CONSIDERED TOO SMALL TO ACCOMPLISH THE TASK ALONE, THE HAITIANS ARE NEGOTATING WITH THE DIRECTORIO REVOLUCIONARIO ESTUDIANTIL (DRE, STUDENTS' REVOLUTIONARY DIRECTORATE) FOR AN ADDITIONAL CRAFT. SINCE THE EXILES FELT THAT THE ASKING PRICE OF \$16,000 IS SOMEWHAT HIGH, THE DEAL WAS STILL PENDING AS OF 16 NOVEMBER.
