

2. [REDACTED] ON [REDACTED] JULY [REDACTED] SAID THAT [REDACTED] HAD OFFERED HIM CASH (AMOUNT UNSPECIFIED [REDACTED]) IN RETURN FOR HIS EFFORTS IN ACTION AGAINST PRESIDENT FRANCOIS DUVALIER OF HAITI. [REDACTED] CLAIMED TO HAVE ORGANIZED [REDACTED] [REDACTED] A POLITICAL GROUP OF 560 HAITIANS IN THE BAHAMAS. SOME WERE BEING GIVEN MILITARY TRAINING FOR ACTION AGAINST DUVALIER. SOME IN THE GROUP ARE FORMER SOLDIERS OF THE HAITIAN ARMY, AND A FEW ARE FORMER LOW-RANKING OFFICERS.



ROLANDO MASFERRER ROJAS, CUBAN EMIGRE AND FORMER CUBAN SENATOR, WERE INVOLVED IN A PLOT AGAINST DUVALIER IN LATE 1965 AND EARLY 1966. MASFERRER, AND OTHERS WERE ARRESTED BY U.S. AUTHORITIES IN JANUARY 1967, INDICTED IN MIAMI BY A FEDERAL GRAND JURY, AND CHARGED WITH CONSPIRING TO LAUNCH AN INVASION OF HAITI FROM THE FLORIDA KEYS. THEY WERE RELEASED UNDER BOND, AND THEIR TRIAL IS SCHEDULED FOR 2 NOVEMBER 1967.)
