1. AS OF 30 AUGUST 1963, ROLANDO MASFERRER WAS IN NEW JERSEY. HE HAD BEEN IN MIAMI AS RECENTLY AS 25 AUGUST, AND WAS PLANNING TO RETURN AGAIN ON OR ABOUT 3 SEPTEMBER.

2. WHILE IN MIAMI PRIOR TO 25 AUGUST, MASFERRER STAYED AT THE HOME OF MIGUEL ANGEL VIVANCO, 328 S.W. 8TH AVE., MIAMI.

3. MASFERRER SAID THAT HE WAS COLLABORATING WITH THE REBEL HAITIAN LEADER LEON CANTAVE, AND WITH TWO DOMINICANS NAMED LUIS FACUNDO AND TOMAS CORTINA, AND THAT HE INTENDED TO PUT A BODY OF MEN ASHORE IN HAITI TO SUPPORT CANTAVE WHO, ONCE IN CONTROL OF THE HAITIAN GOVERNMENT, WOULD


