1. ON ABOUT 10 OR 11 NOVEMBER 1964, A MOVING VAN DEPARTED FROM NEW JERSEY FOR MIAMI CARRYING LARGE QUANTITIES OF ARMS HIDDEN BENEATH A FEW PIECES OF FURNITURE. THE CARGO ALSO IS BELIEVED TO CONTAIN BAZOOKA TUBES, TNT, AND NITROGLYCERINE ELEMENTS. THE ARMS ARE ALLEGEDLY TO BE USED IN A COMBINED HAITIAN/CUBAN EXILE OPERATION DIRECTED AGAINST THE OVERTHROW OF HAITIAN DICTATOR FRANCOIS DUVALIER.
