1. FOLLOWING ARE COMMENTS MADE BY PRESIDENT JUAN BOSCH OF THE DOMINICAN REPUBLIC REGARDING THE HAITIAN/DOMINICAN SITUATION:

A. BEGINNING ON THE AFTERNOON OF [REDACTED] MARCH 1963 THE SITUATION IN HAITI BECAME MORE CRITICAL, AND THE DOMINICAN DIPLOMATIC MISSION IN HAITI MAY BE THREATENED. TROUBLE ON THE DOMINICAN/HAITIAN BORDER COULD ERUPT, AND THE DOMINICAN REPUBLIC HAS TO BE PREPARED FOR ANY EVENTUALITY.
