NATIONAL LEADERS OF THE PARTIDO COMUNISTA MEXICANO (PCM - MEXICAN COMMUNIST PARTY) HAVE RECEIVED REPORTS THAT MEXICAN CATHOLICS ARE PLANNING TO PARTICIPATE IN A PILGRIMAGE TO THE SHRINE OF GUADALUPE, MEXICO D.F. DURING THE VISIT TO MEXICO OF JOHN F. KENNEDY, PRESIDENT OF THE UNITED STATES. THE PILGRIMAGE IS TO BE HELD IN HONOR OF THE PRESIDENT AND HIS WIFE, AND THEY WILL BE INVITED TO WATCH IT.
