The Acting Chief of the Czechoslovak Political Intelligence Service (OBZ) in the Ministry for the Interior, Staff Captain POKORNY, who succeeded General BARTIK following the latter's dismissal, is alleged to have falsified records and documents collected in the interrogation of Karl Hermann FRANK. General BARTIK had been given the right to carry on the entire interrogation of Karl Hermann FRANK, however, following his dismissal the documents were allegedly tampered with to incriminate political enemies of the Communists.

2. It was reported in April that the National Socialist Minister for Justice, Dr. DRTINA, had raised this issue in the provisional government and thus precipitated a fight between the Communist and non-Communist parties.
