1. ALTHO POSSIBLY PARTIALLY REPETITION YOUR CONFERENCE WITH [ ] LATTER STATED HE URGED ARENAS AND OCANA NOT TO BECOME INVOLVED WITH OFFICIAL CONTACTS IN WASH. AS GENERAL PLANS WERE WELL UNDERWAY AND THEIR ACTION WOULD ONLY JEOPARDIZE WHOLE DEAL.

2. ARENAS HOWEVER CONTACTED HIS FRIEND SENATOR KARL MUNDT, SOUTH DAKOTA, WHO REFERRED HIM TO MCCARTHY. LATTER INTERESTED BUT APPARENTLY OFFERED NO TANGIBLE SUPPORT. [ ] UNWARE ANY SPECIFIC PLANS FOR SUPPORT OF ARENAS AND OCANA ALTHO RFCOGNIZED SOME UNDOUBTEDLY EXISTS.

3. PRIOR ARENAS DEPARTURE FOR WSBURNT, HE URGED BY [ ] TO ORGANIZE QUIETLY AND BY ALL MEANS BE PATIENT. [ ] UNWARE OF OCANAS ACTIVITIES AND WOULD BE RECEPTIVE TO ANY SUGGESTION HOW HE MIGHT HELP. WE BELIEVE YOU HAVE COVERED THIS WITH HIM HOWEVER WILL AWAIT YOUR REPORT.

4. [ ] APPEARS THOROUGHLY SOLD ON NEED FOR PATIENCE WHILE DEVELOPING CONTROLS AND A WELL ORGANIZED MACHINE. HE ALSO

UPSET BY ARENAS SOUNDING OFF IN WSBURNT ALTHO UNWITTING OF IDENTITY PERSON INVOLVED (ODACID). HE FEELS ARENAS HAS UNDOUBTFDLY CONTACTED CALLIGERIS (WHICH MAY ACCOUNT FOR APPARENT ACCELERATION LATTER'S ACTIVITIES AS EVIDENCED IN [ ] 772 (IN 49974)). THEREFORE HE WILL CABLE CALLIGERIS VIA HIS [ ] ADDRESS IN SPECIAL CODE REQUESTING CALLIGERIS NOT ACCEPT ARENAS VIEWS AS THEY ARE UNRFLATED TO RFALITY AND TO ADHERE CLOSELY TO PRESENT PLANS.

5. ALTHO NO ASSURANCE OF SECURITY ABOVE CODE IT HAS BEEN USED THUS FAR AND PENDING OUR ESTABLISHMENT OF COMMO NO OTHER RAPID COMMUNICATION WITH CALLIGERIS NOW EXISTS. THEREFORE HAVE AUTHORIZED MYLKES TO CHECK CODE PROCEDURE SECURITY AND RELEASE SAME 17 JAN IN INTEREST IMMEDIATE CLARIFICATION OF SITUATION.

6. WILL CONTINUE ACTIVE EXPLORATION OF WAYS TO COUNTERACT ACTIVITIES SAID PERSONS WITHOUT JEOPARDIZING THEIR ULTIMATE VALUE. MEANWHILE YOUR SUGGESTIONS THIS REGARD WILL BE APPRECIATED.

7. RE AMBASSADOR'S SCHEDULE RECOMMEND LINC BE AUTHORIZED TO REPLY TO GUAT SAKE OF CHANNELS THAT CORRECTIVE ACTION BEING TAKEN. MEANWHILE CONSIDER ARENAS AS ENTHUSIASTIC BUT INACCURATE PERSON.
