Utilization of ORIT for PESSuccess Purposes

1- As directed Mission [ ] has developed contact with ORIT headquarters utilizing the services of RNLABILE.

2- At present RNLABILE is working toward developing joint efforts with ORIT, that is RNLABILE would aid in the preparation of anti-BOGYPSY materials and use ORIT facilities for distribution.

3- Concerning WSBURNT the following is a basic estimate of ORIT on the internal labor situation.

a- ORIT believes that that BOGYPSY control of the labor situation is nearly complete and will continue while the present government remains in power.

b- ORIT does contemplate organizational activities in WSBURNT, the exact nature of which is at present unknown (perhaps not decided upon as yet considering (a)

c- ORIT publications enter WSBURNT freely and on a continuing basis (their mailing list is attached).

d- ORIT officials do enter WSBURNT on legitimate trade union ~~xxx~~ business, however limited. (I believe most ORIT contacts are with Apristas in exile) Organizational Secty. or ORIT, Jauregui is Aprista in exile.

e- ORIT does not believe the present dominant ~~xxxx~~ BOGYPSY group could maintain control without the support of the ~~xx~~ present administration.

4- Based on the foregoing ORIT estimate the following suggestions are advanced.

a- RNLABILE work toward closer collaboration with Secty. Genil Monge of ORIT with the view of working toward increased activity concerning the WSBURNT situation. At present the official ORIT view is that it is not the ~~WSBURNT~~ govt. itself which is doing things of an undemocratic nature ie. agrarian reform etc. but the evil is merely the perverted twist the communists have given to the various government schemes. Since ORIT is allowed freedom within the country they have done nothing to openly alienate the present WSBURNT govt.

b- RNLABILE should attempt after proper cultivation of MONGE to have ORIT introduce more controversial articles and actual anti-WSBURNT propaganda. This undoubtedly would induce the WSBURNT government to suppress the travels and propaganda of ORIT personnel. This will bring down the wrath of ORIT and its parent organization ICTU which numbers more than 50,000,000 members throughout the world. At present this wrath is only directed in Latin America at govts. which actually suppress ORIT activities. ie. Argentina, Peru, Venezuela. The non-Communist labor movement usually only moves when shackles are actually applied to their own activities. Therefore they must be pushed or coerced into activity.

It may be possible that certain contacts within U.S. labor orgs. may be used to supplement the "pushing" of ORIT. It is believed however that it would take quite a bit of ~~xxxxxxx~~ vehement anti-WSBURNT govt. propaganda to ~~move~~ move them to suppression of ORIT activities. The reason--- the label of anti-labor ~~could be~~ applied to them by the powerful non-communist unions who could bring pressures through International Orgs. i.e. I.L.O. U.N. etc.

4- It is possible that for quite some time the WSEURNT govt. would not do anything to hamper ORIT propaganda activities. In that case we may benefit by the increased propaganda output and the prestige of having the most powerful Inter-American labor org. attacking the WSEURNT govt. This increased propaganda too, will do much to convince many leftists among labor groups that they have allies outside the country which consider their "liberal" causes of importance--- therefore taking much steam out of ~~the~~ BCCYPSY propaganda. It is believed that if ORIT could be considered an ally much of the stigma of the return of the old regime might be taken off the anti-BCCYPSY effort.

5- The existing anti-BCCYPSY labor groups in WSEURNT are merely front groups and not legitimate labor entities. They have no representative or bargaining power, therefore they can do nothing for the WSEURNT worker. These can be utilized by existing facilities and undoubtedly are.
