1. THE LACK OF INTEGRITY AND ETHICS DISPLAYED BY LINCOLN IN TREATMENT OF ODOATH COMBAT VETERAN JUVIA 2 AND JUVIA HAS SO SEVERELY SHAKEN MY CONFIDENCE AND TRUST I FEEL I CAN NO LONGER SERVE KUBARK IN ANY USEFUL CAPACITY.

2. THE AID OF JUVIA 2 AND JUVIA WAS ENLISTED TO EXECUTE FT/11. THEY SERVED VOLUNTARILY FROM PURELY IDEOLOGICAL AND PATRIOTIC MOTIVES. BOTH ARE NOW IN NO LITTLE POTENTIAL DANGER BECAUSE OF THEIR GOOD FAITH EXECUTION OR WHAT NOW APPEARS IRRESPONSIBLE LINCOLN DIRECTIVES. 3. CORRELATING ABOVE WITH FACT I HAVE BEEN FORCED TO EXPEND OVER \$9500 OF MY OWN FUNDS SINCE DEPARTURE ON FOREIGN SERVICE 2 SEPT 52, REQUEST ADVISE FOR THE PRECISE PROCEDURE IT IS DESIRED I FOLLOW TO ACHIEVE BOTH RETURN TO PBPRIME AND RESIGNATION FROM KUBARK CONSISTENT WITH ASSURANCE OF:

A. MY LOCAL PRESENCE TO SUPERVIESE PACKING OF HOUSEHOLD EFFECTS AND TERMINATION OF RENTED QUARTERS;

B. PRESERVATION OF CURRENTLY ACCRUED ANNUAL AND HOME LEAVES;

C. PAYMENT OF RETURN PASSAGE FOR SELF AND FAMILY; AND

D. OFFICIAL SHIPMENT OF HOUSEHOLD EFFECTS AND AUTOMOBILE.

4. MY PBPRIME RESIDENCE IS HEREBY OFFICIALLY DESIGNATED AS SAN ANTONIO, TEXAS.
