PLEASE DELIVER FOLLOWING TO JMBLUG FROM ASCHAM:

I HAVE SEEN HOLLAND'S CABLE TO YOU AND WISH STRONGLY TO REINFORCE  
 VIEWS EXPRESSED REGARDING TREATMENT OF CALLIGERIS. I NEED NOT  
 STRESS RESPONSIBILITIES AND LOYALTIES RESULTING FROM OPERATIONAL  
 BACKGROUND WITH WHICH YOU ARE FAMILIAR. NATURALLY I CANNOT  
 JUDGE RELATIVE MERITS OF THE TWO INDIVIDUALS AS I KNOW NEITHER  
 OF THEM PERSONALLY. I DO KNOW THAT CALLIGERIS WAS THE CHOSEN  
 INSTRUMENT TO EFFECT A HIGH OBJECTIVE AND THAT HIS ACTIONS HAVE  
 CONTRIBUTED MIGHTILY TO THAT END. HE HAS ~~BORNE~~ BORNE THE RISKS AND  
 IF HE WERE NOW TO FEEL THAT HE HAD BEEN DOUBLE CROSSED NOT  
 ONLY WOULD OUR MORAL POSITION SUFFER BUT WE WOULD BE INCURRING  
 THE GRAVEST OF SECURITY RISKS. MY GREAT ADMIRATION FOR YOU  
 PERSONALLY AND FOR THE SKILL WITH WHICH YOU HAVE HANDLED THIS  
 MATTER MAKES ME FEEL THAT THIS MESSAGE IS PROBABLY UNNECESSARY.
