1. OBVIOUSLY, VITALLY INTERESTED IN KEEPING INSPECTION TEAM AS LONG AS POSS IN GUAT. DESIRABLE TO HAVE PROPOSALS FOR MORE DETAILED INSPECTION, TO BE EXTENDE THROUGHOUT COUNTRY NOT LIMITED TO CAPITAL, COME NOT ONLY FROM FBPRIME MEMBER BUT SEVERAL OTHERS, TOO. VIEW MARTIAL LAW, TERROR IN GUAT CANNOT EXPECT ANYBODY VOLUNTEERING OPPOSITIONAL EVIDENCE OR STAGING DEMONSTRATIONS.

2. SUGGEST FOLLOWING DEMANDS BE MADE WHEN INSPECTION TEAM ARRIVED GUAT (NO ADVANCE WARNING). NOT KNOWING TEAM'S TERMS OF REFERENCE OR WORKING METHOD, NOT S WHETHER OUR IDEAS APPLICABLE:

A. ALPHEM SHIPMENT. REFERENCE TO FALSE CARGO MANIFEST. COMPARE TYPE, V SHIPMENT TO WEAPONS STORES IN NEIGHBORING COUNTRIES. ASK TO EXAMINE ARMS STORES.

B. POLITICAL BACKGROUND. PERSONS NOW IN ASYLUM FOREIGN EMBASSIES GUAT C PROBABLY MOST EFFECTIVE WITNESSES SINCE UNDER DIPLOMATIC PROTECTION. TO BE QUESTIONED RE POLITICAL TERROR PRIOR TO "INVASION", POLICE TORTURE METHODS, LOOTI HOUSES OF EXILES, ETC. WITNESSES WITH LEGAL BACKGROUND RE ARBENZ VIOLATIONS GUAT CONSTITUTION, ARTICLE 32, CIVIL RIGHTS, CASE OF RADIO INTERNACIONAL.

C. VISIT SALAMA PRISON. POLITICAL PRISONERS HELD WITHOUT TRIAL OVER YEA RECENTLY RUMORED LIQUIDATED, PROBABLY UNTRUE BUT EVEN SO FLAGRANT CASE DENIAL DUE PROCESS.

D. INSPECT CHURCHES WHICH GUAT GOVT REPORTED DESTROYED, LA MERCED IN GU CITY, OTHERS IN PROVINCES. DEMAND GUATS PRODUCE "FOREIGNERS" AMONG CAPTURED CAS FOLLOWERS, ONE MAIN SUPPORT THEIR CLAIM OF "INTERVENTION." DO EVERYTHING PROVIN GUAT GOVT LYING.

E. QUESTION TORIELLO HOW HIS STATEMENT AT PRESS CONFERENCE SHORTLY AFTR ARRIVAL ALFHEM THAT NO OTHER ARMS SHIPMENTS COMING COMPARES WITH SHIPMENT INTERC HAMBURG.

F. INVESTIGATE CARRIBBEAN LEGION, FOREIGN COMMIE ACTIVITIES IN GUAT DIRE AGAINST OTHER COUNTRIES, ETC. AS BASIS CLAIM GUAT ENDANGERING PEACE OTHER COUNTR NOT VICE VERSA.

G. TRY AT LENGTH OBTAIN EVIDENCE OF GUAT AIR ATTACKS AGAINST HONDURAS.

H. EXAMINE INTO ORDER TO ARREST NON-COMMIES AND SHOOT WHEN ATTACK BR DC AS EVIDENCE INTERNAL UPRISING AGAINST LAWLESS BRUTAL REGIME.

3. FOR ARRIVAL TEAM HONDURAS, BOTH OUTSIDE DEMONSTRATIONS AND INTERNAL EVIL COULD BE PREPARED, INCLUDING:

A. VISIT SCENES UNIDENTIFIED BOMB DROPS

B. EVIDENCE GUAT INTERFERENCE HONDURAN STRIKES

C. CLANDESTINE NEWSPAPER HONDURAN COMMIE PARTY PRESUMABLY PRINTED GUAT

D. WHY SEVERAL GUAT CONSULS WERE DECLARED PERSONA NON GRATA

E. COMPARISEN HONDURAN ARMED FORCES WITH GUAT ARMED POTENTIAL, PROVING HONDURAN AGGRESSION OUT OF QUESTION

F. INSPECTION RECENT U.S. FURNISHED ARMS, SHOWING THEM ALL PRESENT AND

ACCOUNTED FOR.

G. COLLECTION OF HOSTILE GUAT RADIO, PRESS STATEMENTS INSULTING HONDURA ITS PRESIDENT, ETC., TO BE PRESENTED BY HONDURAS FOREIGN MINISTRY.

4. MORE IMPORTANT THAN DETAILS FOR U.S. TO RESUME DIPLOMATIC INITIATIVE, A PREVIOUSLY RECOMMENDED. OUR CASE IS LOST, UNLESS WE COUNTERATTACK GUAT-MOSCOW A INSTEAD OF APOLOGIZING FOR UNPROVEN SUPPORT WHICH IN ANY CASE WOULD BE ONLY FRAC OF COMMIE SUPPORT OF CIVIL WARS EVERYWHERE. REITERATE DESIRABILITY TO OFFER GUA ARBITRATION UFCO CLAIM BEFORE WORLD COURT, AS EFFECTIVE MEANS DISSOCIATING UFCO INTEREST FROM U.S. GOVT. STAND AGAINST COMMIE INFILTRATION WESTERN HEMISPHERE. DEPT. MIGHT ALSO PRESENT TO U.N., O.A.S. SUMMARY OF WORLD WIDE COMMIE CAMPAIGN SUPPORTING GUAT TO ILLUSTRATE THAT ARBERZ MOSCOW'S SATELLITE.
