1. HEADQUARTERS HAS RECOMMENDED TO ODACID THAT BLUG BE INSTRUCTED
ISSUE STATEMENT RE REASONS ODYOKO DECISION EVACUATE THOSE CITIZENS DESIRING
LEAVE AND THAT ^{you} BE AUTHORIZED FREEDOM AS TO CONTENTS WHICH IN HEADQUARTERS
OPINION SHOULD BE AIMED AT U.S. AS WELL AS INTERNATIONAL REACTION. WE HAVE
RECOMMENDED STATEMENT BE STRONG IN ORDER ACHIEVE MAXIMUM IMPACT AND UTILIZA-
TION.

2. HAVE SUGGESTED TO ODACID FOR JMBLUG GUIDANCE FOLLOWING LINES RE
WHICH LINC'S SUGGESTIONS REQUESTED EARLIEST.

- A. EXISTING THREATS TO LIVES AND PROPERTY.
- B. REPORTED ARMING OF CIVILIAN GROUPS. REPORTS FROM RELIABLE
EYEWITNESSES OF ROVING BANDS ARMED CIVILIANS WHICH, ALTHOUGH ACCOM-
PANIED BY POLICE, OBVIOUSLY UNDISCIPLINED AND MIGHT TAKE VIOLENT
ACTION IF AGITATED BY COMPIES OR PROVACATEURS.
- C. REPORTS OF THREATS AGAINST U.S. EMBASSY AND PERSONNEL AND
OTHER AGAINST EMBASSIES AND PERSONNEL THOUGHT TO BE FRIENDLY TO U.S.
