1. FYI HQS HAS INFORMALLY CONTACTED OFFICIALS CERTAIN PRIVATE PBPRIME COMPANIES SUPPLYING WSBURNT GAS/FUEL OIL WHO MAY ANNOUNCE UNWILLINGNESS SHIP FURTHER SUPPLIES WSBURNT GENERALLY FOR FOLLOWING REASONS:
