1. FIRST TWO DAYS CONGRESS INCLUDED PRIETO LAURENS ACCUSATIONS AGAINST COMMIES IN MEXICAN GOVT; SPEECHES BY URIBE MISAS, PENNA BOTTO, BAQUERO DE LA CALLE, ANDRES DE CICCO, JOSE LUIS ARENAS ALL TREATING COMMUNISM THEIR COUNTRIES, HEMISPHERE AND GUATEMALA. MEETINGS ORDERLY BUT BEHIND AGENDA SCHEDULE. DELEGATES SELECTED BY MISSIONS MADE EXCELLENT IMPRESSIONS, ESPECIALLY PENNA BOTTO, BAQUERO DE LA CALLE. SOURCES PRESS, RNSHIELD AND NASHWINTER.

2. FULLY DOCUMENTED GUAT CASE PRESENTED BY JOSE LUIS ARENAS THIRD DAY. RESOLUTION PASSED TO PRESENT GUAT CASE BEFORE OAS. COMMISSION APPOINTED AS PREVIOUSLY INDICATED WITH PENNA BOTTO AS PRESIDENT, PRIETO LAURENS AS SECRETARY GENERAL AND SUBSTITUTION RAFAEL VELASQUEZ FOR URIBE MISAS OF COLOMBIA. SIEGRIST FACTION CNE AND FUA TRIED DISRUPT MEETING. WERE EXPELLED FROM HALL, BUT SUCCEEDED GAINING PRESS EMPHASIS 30 MAY. DISTURBANCES PLUS LAURENS CONTINUED BLAST MEXICAN GOVT FOR CODDLING COMMIES CAUSED WALKOUT ECUADOR AND COSTA RICA DELEGATIONS. MAY RETURN FOR 30 MAY SESSION.

PARAGUAY: ISABEL URRUA VALLAJO (ALSO RCVD VALLEJO). PANAMA: LUIS CARLOS NORIEGA AND ARTURO HASSAN ANTEMEZ. NICARAGUA: CARLOS ADAN ESPINOZA, JULIO SERPAS AND FRANCISCO PEREZ ESTRANA OF CNTDN. PERU: SEN NESTOR GAMBETTA AND LINCOLN PINZAS GALLARDO, VP OF PERUVIAN CHAMBER OF DEPUTIES. COSTA RICA: MARIANO QUIROZ GONZALEZ.

4. INTERIM EVALUATION CONGRESS:

A. SUCCESS FOR PBSUCCESS SINCE ALL DELEGATIONS SPOKE AGAINST SOVIET INTERVENTION GUATEMALA AND ENTHUSIASTICALLY APPROVED RESOLUTION CONDEMNING SUCH INTERVENTION FOR FORWARDING TO OAS. OPPOSITION UNITED-LIBETHENITE-4 DID NOT ATTEND OR ATTEMPT DISRUPTION.
